I. Call to Order and Roll Call

II. General Public Comment

III. Old Business:

The committee voted to table discussion of old business until the April 7th meeting.

IV. New Business : Cap and Trade Grant Funds

A. **Paula's Report on Cap and Trade (C & T) Funds**: C & T funds are collected by the State of California from high greenhouse gas (aka GHG) producers like utility companies and are granted to fund large (eg. high speed rail) and small GHG reduction projects. They are administered by the California Air Resources Board which distributes them to 14 agencies. (Those distributing to neighborhoods are Strategic Growth Council, Cal Trans, and Cal Fire). Grants can be given to neighborhood councils who work in partnership with Council Districts, City Departments, and 501c3's and which must be implemented in low income, high

unemployment areas of the City, or which serve to connect this population to home, workplace, and services.

B. Paula Waxman (Green Team) and Jon Liberman (Transportation Committee) asked for ideas from the committees which might qualify us for these funds. Although the majority of the SORO district does not meet the qualifications of low income, high unemployment, the population along the east border of the SORO community does qualify. It is also true that there are two Expo Train Line Stops along the south border of SORO. If these stops can be connected by bus to Century City and Beverly Hills to the north, and Culver City to the south, it would provide a way for low income folks to get to jobs from those train stops. These were the ideas that were discussed:

1. Pedestrian walkway improvements (which would include shade trees) to and from Expo stops. An enhanced focus on pedestrian safety and mobility across major tributaries like Robertson and La Ciengga at regular intervals

2. Connector bike paths, and lanes. To be discussed with Michelle Mowry, DOT We need to study existing bike lanes, paths, bike friendly streets, signage to see how we can make them better serve our goals and needs.

3. Electric Buses through residential areas to Beverly Hills, Century City

4. Increased frequency of all existing bus routes

5. Conversion of alleyways to "people streets". Discussed possibly converting alley to promenades in La Cienega Heights.

E. Research requested from Joe Galloway, Councilman Koretz's office

1. Does the City DOT already have plans to connect the Expo stops at Washington/National and Palms/National by bus to Century City, Beverly Hills, and Culver City and what those plans are?

2. Who to contact at the above City Agencies for input and advice.

3. Discuss with Councilman Paul Koretz to see if he would help draft/support a possible plan

4. Specifics in the Mobility Plan 2035 that deal with future development of these transit hubs in #1.

5. Long and short term plans for the Expo Line Parking lot at National and Washington including number of parking spaces temporarily lost/gained, permanently lost/gained and how long this lot will be under construction.

6. Are alleys private or public? Can promenade/people streets be created? What are issues for consideration?





7. Who can advise us on future expected development/density allowances made under new legislation and commensurate impact on mobility?8. Joe Galloway to provide Overland Development Plan as sample prototype and author contact information.
