

III. New Business:

a. Education:

i. Evening Presentation:

Jason Benavidez of The Pharmacy Depot: "How, Where and Why to Correctly Dispose of Medications". The Pharmacy Depot, 4972 W Pico Blvd, Los Angeles, CA 90019 (323) 965-0580 Provides a local drop-off site for unused medications and is helping to educate about the negative effects of improperly disposing of pharmaceuticals.

Walgreens sells envelopes for \$2.99 where you can put your unused prescriptions in and ship them out. Also Police departments will accept them. But only 2 pharmacies in LA accept unused prescriptions.

ii. Future Presentations:

- Al Gore's Climate Reality Project. Paula suggests having a presentation at Isaiah Temple. We were all in agreement to do this.
- Lisa Novick, of the Theodore Payne Foundation. Paula mentioned that one of the Foundation's goals is to promote the use of native plants because they are habitats for California Wildlife. Saran mentioned that we should have TP at the Soro

- 3. James Brennan, Community Solar Program. Paula was approached by him to help promote Solar programs in our neighborhood and get a reduced rate.

- 5. Paula Daniels, LA Food Council. The Los Angeles Food Policy Council (LAFPC) is a collaborative network of 35 Los Angeles regional food system leaders, working to make Southern California a Good Food region for everyone- where food is healthy, affordable, fair and sustainable. Through policy creation, new cooperative relationships, and systemic change, its goals are to reduce hunger, improve public health, increase equity in our communities, create good jobs, stimulate local economic activity, and foster environmental stewardship.
