

In view of plan's failure to resolve and mitigate critical issues per the Statement of Overriding Considerations, including but not limited to, emergency response time, insufficient infrastructure, and broader significant negative impacts on public health, safety and welfare. The final EIR concluded that... the MP 2035 would result in the following unavoidable significant adverse impacts that are not able to be mitigated to a less-than-significant level: transportation (circulation, neighborhood intrusion, congestion management plan and emergency access); noise and vibration (excessive noise from buses and permanent noise increase from buses); and biological resources (sensitive species/habitats, Wetlands).
- c. Discussion Of JMB Realty project located at 1950 Avenue of the Stars as to whether the proposed changeover, from a commercial project to revert back to a residential project, so significantly changes the environmental consequences that the mitigations approved for the project (when it was proposed as a commercial project) are no longer sufficient. If a consensus that the impacts of the change outweigh the proposed relief provided by the existing mitigations; the committee needs to determine whether we want to propose that the NC request that the LA City Planning Commission be asked to rescind the current permits until the revised impacts can be studied.
- d. Discussion of the proposed development of the Robertson Station Expo Parking Lot located in Culver City as to what is being proposed and whether this proposed development has:
  - (i) considered the effect of reducing parking by 300 spaces adversely effects Transportation and LUED considerations in Soro.
