#### Joint discussion with SoRo, Inc.

Mary Earl and Larry DeMers from SoRo, Inc. attended to discuss methods of increasing our respective impact in the community.

SoRo Inc is exploring the possibility of a name change to better differentiate the organization from SORO NC. Discussed whether SORO Inc. could act as fiscal sponsor for community programs and grant applications. Discussed possibility that SoRo Inc could establish its own community grant process to complement the NC's. Will explore with City Attorney the contours and limits of joint endeavors.

Will present to the new NC Board at the January meeting. Next joint exec meeting tentatively scheduled for February.
