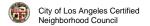



Motion to Request Removal of Overnight Parking Restrictions on the Blocks of 18th Street Adjacent to La Cienega Plaza

Background

There is currently a restriction for "no overnight parking between 11:00PM-5:00AM" on the blocks that run alongside La Cienega Plaza, south side of 18th Street, from La Cienega to Holt

The signs had been originally requested the to stop the prostitution and drug sales at night along the mall. Since, these crimes are no longer a problem in the area, there is no longer a need for these restrictions.

As the City allows granny flats and new units with reduced parking requirements, adding to an abundance of multi-family units in the neighborhood, the street parking in that area is limited and pushes people to park on streets north of 18th Street.

During COVID-19, restrictions were relaxed in that same area and it has greatly helped with parking in the La Cienega Heights area and surrounding neighborhoods.

LADOT requires letters from SORONC, CD-10 and LAPD requesting the permanent removal of existing restrictions. Last year, the SORO NC approved sending letters requesting removal of similar signs along Sawyer, between La Cienega and Holt and the 1800 block of Holt on the east side of the street. (Surrounding La Cienega Plaza.)

Proposed Motion

1. That the South Robertson Neighborhoods Council (SORONC) requests that CD-10 and LAPD write letters in support of removing the restrictions that were placed due to crimes in the past. Review of the LAPD crime stats show that there is no longer an issue. The SORONC requests that LADOT remove the no overnight parking between 11:00PM-5:00PM restrictions on the South side of 18th Street, from La Cienega to Holt.

Dear Captain Tom,

The South Robertson Neighborhoods Council (SORO NC) has taken a vote to request that the overnight parking restrictions on the south side of 18th Street, from La Cienega to Holt. The matter was brought through the SORO NC's Public Safety Committee at the request of Stakeholders in Crestview and La Cienega Heights.

A few months ago, we had requested and were granted the removal of the Overnight Parking Restriction on the north side of Sawyer from La Cienega to Holt and on the east side of Holt from Sawyer to 18th Street. For the same reasons as the previous request (lack of part 1 crimes, need for neighborhood parking), we are requesting the removal of the overnight parking restrictions on the aforementioned section of 18th street.

As a reminder of the background for the installation of the restriction.

The overnight parking restrictions were installed when La Cienega Heights was called Coring-Cadillac and the PBGs and DIMs ran drugs and prostitution in the area and used Sawyer as their afterhours marketplace. In 2007-2008, community members worked with the LAPD to get rid of the crime, drug sales and prostitution that was ran out of 1937 Corning and 1975 Garth. Connie Collins and Terrence Gomes worked with the Council Office to reimage the area and rename it La Cienega Heights. Since that time, property values have risen to a point that houses in the area that are selling for over \$1 million. We are also seeing developers building 5 story condos selling for over \$1 million each. The developers are also building small lot sub-divisions by tearing down 1950's ding bat apartments and building five to six single family homes on a lot. Due to La Cienega Heights being in a TOD, developers are required to provide less parking causing more cars to be on the street and creating more parking problems north of La Cienega Heights in Crestview.

As with the previous request, LADOT requires a letter from LAPD and CD 10 to have the overnight parking restrictions removed. We hereby request for you to send a similar letter from LAPD to CD 10 Councilmember Mark Ridley-Thomas. A copy of the previous letter has been attached for your convenience.

The SORO NC appreciates your assistance with this request, as well as your continued service and support to the Stakeholders of South Robertson.



Background

Since 2017, the property at 8755 W. Olympic Blvd. and it's owner have been the subject of investigation and litigation involving several LA Department of Building & Safety (LADBS) and LA Fire Department (LAFD) violations.

There was a sub-lease individual that brought serious problems into the property. It took a long time and significant cost, but the owners were finally able to evict this individual. The owners have reported that all reported violations have since been cleared by LADBS. However, the City Attorney's criminal case against the property owner continues to drag on.

The property owner's intention is to sublease this property to the city of Los Angeles, to be utilized to house homeless individuals or families and provide them with access to city services. Dismissing this case will allow for negotiations with the City of Los Angeles to begin, leading to help benefit solving the Homeless crisis in the area.

Proposed Motion

 That the South Robertson Neighborhoods Council (SORONC) write a letter to Deputy City Attorney Serena Christion and Commissioner Harris to request the dismissal of Criminal Case # 8CJ012327 against the owner of 8755 West Olympic Boulevard, with the condition that the property be available for negotiations with the City of Los Angeles to be used for the benefit of the Public.

The South Robertson Neighborhood Council is sending this letter to you in support of the dismissal of Criminal Charges with prejudice against the Jewish Educational Movement organization in Case #8CJ012327.

The property owners have worked diligently and invested a lot of time and money fixing the LADBS and LAFD code violations occupancy of 8755 W Olympic Blvd. There was a sub-lease individual that brought serious problems into the property. It took a very long time but they were finally able to evict this individual and the problem's he brought into the property. Rabbi Illulian has assured us that the violations have been corrected and the building is in compliance. There have not been any new complaints to LAPD or LADBS regarding the property for many, many months.

There is a greater value to the community to put this Assisted Living Facility to immediate availability to be leased to the City of Los Angeles. We are in a crisis. There is no benefit for the courts or the city to waste more time and money on prosecuting these LADBS and LAFD violations which have been corrected.

Rabbi Illulian, on behalf of the Jewish Educational Movement, is ready and willing to lease this property to the City of Los Angeles to be utilized for "Bridge Housing" or another similar program at the discretion of Council District 5. This would be a tremendous benefit to the community and help to alleviate the homeless crisis. Council District 5 is struggling to find appropriate locations for city funded projects to help the homeless crisis. There is crisis in our city right now.

The building at this property is designed as an Assisted Living Facility. Let it be used to assist in the homeless crisis. which the city can benefit from. It is located in the South Robertson Neighborhood Council district. This will be a big asset to South Robertson Neighborhood Council ability to do their part to support our unhoused neighbors.

Please dismiss this case for the betterment of the community and allow this property to be utilized to help alleviate the homeless crisis in Los Angeles.

Fix the problem, not the blame.



Motion to Request City Council Members to Communicate Stakeholder Outrage and Concern to LA District Attorney George Gascón Over Policies

Agenda Item: GB061721-07 **Date:** June 17, 2021

Background

Upon taking office in December 2020, George Gascón has instituted several reform policies within the LA County District Attorney Office. Although these reform policies may be beneficial to defendants in criminal cases, they have resulted in negative consequences to the residents and businesses of Los Angeles.

Stakeholders in the SORO NC boundaries have expressed grave concern regarding the increase in crimes in the area, experiencing a growing number of burglaries, robberies, and violent assaults. Many of the policies of District Attorney Gascón are severely exacerbating the situation, especially those policies that end cash bail and the practice to ban sentencing enhancements, among others.

Our police officers spend countless hours to arrest suspects of criminal activity, only to have them right back on the street to commit more crime. Year-to-date crime statistics show city wide homicides up 21.6%, shooting victims up 58.7%, aggravated assaults up 8.8%, and motor vehicle thefts up 12.8%.

In South Robertson specifically, we recently had an event where one of our residents was the victim of a violent assault. This was caught on video, which led to the arrest of the suspect with an extensive criminal record and gang ties. This dangerous suspect was released into the public (without any bail) and had subsequently not shown up to scheduled court hearings until June 7th- and may very well skip his trial with extraordinarily little repercussions under Gascón. This would never have happened under any previous DA.

As of June 3rd, seventeen other cities have taken vote of no confidence against the District Attorney, including Beverly Hills, Santa Clarita, Arcadia, Manhattan Beach and Lancaster. DA Gascón's directives are





placing the safety of the general public at risk. DA Gascón's policies are restricting victims' rights and imperiling the safety of South Robertson and residents and businesses of Los Angeles.

Proposed Motion

- I. communicate our Stakeholders' concern and outrage directly to LA County District Attorney George Gascón regarding his policies.
- II. send DA Gascón's response immediately to the SORO NC.

The South Robertson Neighborhoods Council (SORO NC) would like to bring to your attention, and strongly request that LA City Council take immediate action regarding criminal policies of Los Angeles County District Attorney George Gascón.

Stakeholders in the SORO NC boundaries have expressed grave concern regarding the increase in crimes in the area, as well as around Los Angeles. We have experienced a growing number of burglaries, robberies, and violent assaults, among others. We acknowledge that there are several reasons for this increase, however many of the policies of District Attorney Gascón are severely exacerbating the situation. Specifically, those policies that end cash bail and that ban sentencing enhancements, among others.

Our police officers spend countless hours to arrest suspects of criminal activity, only to have them right back on the street to commit more crime. Year-to-date crime statistics show city wide homicides up 21.6%, shooting victims up 58.7%, aggravated assaults up 8.8%, and motor vehicle thefts up 12.8%.

In South Robertson, we had an event several months ago where one of our residents was the victim of a violent assault. This was caught on video, which led to the arrest of a suspect with an extensive criminal record and gang ties. This dangerous suspect was released into the public (without any bail) and had subsequently not shown up to several scheduled court hearings (until June 7th) - and may very well skip his trial with extraordinarily little repercussions under DA Gascón. This has never happened under any previous DA.

As of June 3rd, <u>seventeen</u> other cities have taken votes of no confidence against District Attorney Gascón- including Beverly Hills, Santa Clarita, Arcadia, Manhattan Beach and Lancaster to name a few. DA Gascon's directives are placing the safety of the general public at risk. DA Gascón's policies are restricting victims' rights, as well as imperiling the safety of South Robertson and the residents and businesses of Los Angeles.

Again, the SORO NC strongly requests that you communicate our Stakeholders' concern and outrage directly to Mr. Gascón, regarding his policies and directives. We also look forward to your immediately relaying his response within 60 days to the SORO NC, as well.
