# Background

Recently, the City of Los Angeles reclaimed control of Venice Boulevard from the California Department of Transportation (CalTrans), including funds to bring the roadway into a state of good repair. This funding represents an opportunity to improve some of the key concerns the community has with Venice Boulevard, such as safety, mobility, emissions/climate change, and quality of life.

To address these pressing concerns, the following items should be prioritized:

- 1. Protected bicycle/mobility lanes
- 2. A dedicated 24/7 bus lane
- 3. Pedestrian improvements (including consistent sidewalks, improved crosswalks, curb extension, sidewalk repairs, leading pedestrian intervals, disabling of pedestrian push buttons, pedestrian-scale lighting)

Accordingly, the Palms Neighborhood Council and Neighbors United of Faircrest Heights recently sent a nearly identical letter.



Re: Support for Venice Blvd For All

Dear City Leaders,

On behalf of the residents of South Robertson Neighborhoods Council (SORO), we request that the Council Office work with the Los Angeles Department of Transportation (LADOT) to make improvements to Venice Boulevard.

Recently, the City of Los Angeles reclaimed control of Venice Boulevard from the California Department of Transportation (CalTrans), including funds to bring the roadway into a state of good repair.

SORO believes that the Venice Reclamation Fund represents an opportunity to improve some of the key concerns the community has with Venice Boulevard. Using the funds to simply repave and restripe the street as it is would not solve community concerns around safety, mobility, emissions/climate change, and quality of life. Additionally, the Venice Reclamation Fund can and should be used to meet the goals of the City's Mobility Plan 2035, the City's Vision Zero Action Plan, and the City's Green New Deal.

Therefore, SORO requests the following improvements to Venice Boulevard. SORO acknowledges that there are tradeoffs when redesigning a street and requests that the following items be prioritized:

- Protected bicycle/mobility lanes (as specified in the Mobility Plan 2035)
- 2. A dedicated 24/7 bus lane (as specified in the Mobility Plan 2035)
- 3. Pedestrian improvements (including consistent sidewalks, improved crosswalks, curb extension, sidewalk repairs, leading pedestrian



# Motion to support proposed 15-unit TOC at 1059 S Holt

#### **Background**

The project team presented this project to the Land Use Committee at their October 6, 2020 meeting. The project consists of 15 units, including 2 units for Extremely Low Income household occupancy. The project is consistent with the by right use per the TOC program.

- Planned height increase from 45' to 57'-7"
- Side yard reduction (2 yards) of 30% from 8' to 5.6'
- Open space reduction of 24.5%

The subject property, located at 1059 S Holt, is just north of the heart of Pico-Robertson. The adjacent properties consist of residential apartments.

The subject property, a single family home, is 6,411 square feet and located in the [Q] R3-1-0 Zone. The proposed building is a 15-unit 5 story apartment project and utilizes a TOC Tier 3 Incentive program to increase FAR from 3:1 to 4.5:1 and a density increase from 9 units to 15 units.

The owner of the single family home is actively involved in the development process. Despite some concerns from neighbors, the project is worthwhile because it creates density without displacing current residents and locates new multi-family development in proximity to transportation corridors and high activity areas acting as a buffer between said transit corridors and commercial development and existing lower density residential development.

The applicant noticed residents within 500 feet of the property for the Land Use Committee meeting. There were some residents in attendance.

The Land Use Committee voted unanimously to recommend the General Board support the project.

# Motion to support the 57-unit Eldercare Facility at 843-847 S Sherbourne Dr

#### **Background**

The project consists of 56 units in a 7-story, 67-foot high building with 40 automobile parking spaces within 32,120 square feet of floor area. The facility consists of 48 Assisted Living Units and 8 Alzheimer's/Dementia Care Units. A kosher kitchen is a key feature of the building, providing kosher food to those residents that request it. The building adheres to all setbacks except for a raised rear deck and a light well in the front yard. The application includes the following entitlement requests.

 To allow 56 rooms with a height/FAR at 67-feet/4.5:1, consistent with TOC Tier 3.

The subject property, located at 843-847 S Sherbourne Dr, is at the edge of the city border with Beverly Hills. The adjacent properties consist of 2- to 4-story multi-unit apartment buildings.

The applicant noticed residents within 500 feet of the property for the Land Use Committee meeting. There were many residents in attendance to ask questions and provide comment on the building. The majority of commenters were in opposition to the project due to concerns ranging from the size and height of the building to traffic, and the fact that the same developer is already in the process of creating an Eldercare Facility nearby.

The Land Use Committee voted to recommend the General Board support the project contingent on the project team demonstrating at the time of the General Board meeting a good faith effort to address four recurring neighbor concerns: the parking availability in the neighborhood, the design of the building façade, the privacy concerns of the buildings next door, and outreach issues pertaining to the demolishing of currently existing rent-controlled units.

The project provides 56-units of much-needed senior living space in a neighborhood that allows locals to "age in place."

12 market-rate rentcontrolled apartments will be demolished (tenants already evicted).

**Arguments against:** 

While the list of concerns from the neighborhood is long, granting the minimal entitlement request allows for a building that is appropriate for the site and that fits in the existing context of the neighborhood and its aging population.

Developer already has existing similar facility close by.

56 new units – 12 existing units = 44 net new units

Building design is different from neighborhood's appearance.

Neighbors felt they were not notified early enough to research.





#### Dear Captain Tom:

The SORO NC would like to recognize the success of the LAPD Community Policing program, and specifically praise the Senior Lead Officers that have been assigned to the South Robertson area over the past 4 years. They have regularly interacted with Stakeholders at Public Safety Committee meetings and are an important part of several annual SORO NC sponsored events such as Coffee with A Cop, SOROFEST and the Los Angeles Homeless Count.

Among the numerous emails, calls and reports the Public Safety Committee has received about LAPD, there has been a growing number of good comments from the community regarding how our SLOs are addressing situations and affecting positive outcomes in their service to South Robertson.

- SLO Chris Baker- Town Hall meetings addressing Anti-Semitism in the Jewish Community
- Neighborhood Watch Meetings (multiple).
- SLO Chris Baker- Personally walking the beat on Pico Blvd., proactively identifying Safety needs of businesses and religious institutions along Pico Blvd.
- SLOs Chris Baker and Matt Kirk- Personal dedication to protecting Houses of Worship from terrorism threats.
- "Active Shooter" Training presentations in the community.
- SLO Matt Kirk- has been very responsive in dealing with Gang graffiti and communication with the WLA Gang unit on their activities.
- SLO Chris Baker- Coordinated with Narcotics officers and City Attorney to shut down illegal marijuana dispensaries and drug trafficking.
