Background

LAPD has special units dedicated to dealing with homelessness. This way any issues with homeless encampments do not use up our regular Basic Car resources. The transient unit is trained and experienced in dealing with these issues. They often work together with HOPE (Homeless Outreach and Proactive Engagement) teams to try and get homeless people into services that can help them.

The West LA division of LAPD, which includes SORO, does not have its own fulltime transient unit. This is despite West LA having significant homelessness issues, especially near the VA Hospital and the borders of Beverly Hills and Culver City.

We believe that West LA needs its own transient unit to best address the crises in our community.

Proposed Motion

- I. SORO NC shall adopt the position that the West LA division of the LAPD should have a fulltime transient unit permanently assigned to it.
- II. The attached letter should be sent to the LAPD West LA Command staff.

Dear LAPD West LA Command Staff:

Our entire city is experiencing a homelessness crisis. This problem is felt acutely in our neighborhoods in South Robertson. We have multiple encampments in our area. We believe that among other steps necessary to address the problem West LA Division requires a Transient Unit dedicated permanently to the division. The Transient Unit is best equipped to deal with the problem and prevents us from having to divert our few Basic Cars to this issue. West LA has the VA hospital in its territory and borders the cities of Beverly Hills and Culver City which have different policies towards the homeless than Los Angeles does. We believe that the problem in West LA warrants this resource.

The need for this is the official position of our council as adopted by a vote of our General Board. We ask that you work to make it happen and let us know if we may be of any additional assistance in that regard.

Lastly, we wanted to express our sincere condolences to the division on the death of Officer Juan Jose Diaz. We are with you in mourning his loss. We appreciate all the work you do and the risks you and your officers take to protect our communities.

Background

The City Council is the governing body of the City, except as otherwise provided in the Charter, and enacts ordinances subject to the approval or veto of the Mayor. Except as otherwise specifically provided in the Charter, the Council shall have full power to pass ordinances upon any subject of municipal concern.

City Council has ultimate authority over all matters. Charter Section 250(b) provides that the Mayor's failure to act on an ordinance within ten days makes the ordinance, as if the Mayor had signed it. Section 250(c) provides that a mayoral veto can be overridden by a two-thirds or three-quarters vote of the Council.

When City Council passes a motion and includes, SUBJECT TO THE APPROVAL OF THE MAYOR, it negates Charter Section 250(b) and allows the Mayor to sit on a Council Motion for an indefinite amount of time and negates Section 250(b) as it does not allow the City Council to override the Mayor's decision.

Proposed Motion

The South Robertson Neighborhoods Council realizes that the City Council is voted in by the citizens of Los Angeles to represent their interests and make decisions. The Mayor of Los Angeles has the power to veto those decisions. The South Robertson Neighborhoods Council demands that the City Council no longer use the term "SUBJECT TO THE APPROVAL OF THE MAYOR" in Council Files.

Various organizations and levels of government created presentations to expand awareness and knowledge of how to act (react) in an active shooter situation. The SORO Public Safety Committee had one such presentation a few years ago at its monthly meeting that received high praise.

Motion to request LA City Council initiate a study on addressing safety concerns regarding residential parkway landscape regulation Agenda Item: GB091919-11

Background

As a result of recent draught activity and previous LA City Residential Parkway Guidelines, property owners have been replacing their parkways with drought tolerant native plants and other materials, such as gravel, wood chips, stones, artificial turf, or resort to spraying multiple applications of ROUNDUP®. Although environmentally conscious, each of these may pose a serious health and safety risk to the general public, as well as liability to the City

Among many possible safety concerns are:

- Gravel, stones and woodchips do not stay where placed and are easily transferred from the parkway area an onto the sidewalks and streets. This poses a hazard for pedestrians.
- Drought tolerant plants are great however, their needs to be regulation on what types of plants are permitted. Cactus with spiky growths can be dangerous and should not be allowed to be planted in the parkways. There is also a very popular succulent that is called Fire Stick Succulent or Pencil Succulent (Proper name: Euphorbia tirucalli) that produces a milky substance that is extremely acidic and toxic to humans and pets.
- ROUNDUP® contains Glyphosate. Glyphosate has been linked to Non-Hodgkin's Lymphoma. Multiple lawsuits have been won against the Bayer who bought ROUNDUP® from Monsanto.

The regulation of LA City residential parkways needs to be updated to keep the public right of way safe for pedestrians, children and pets.

Proposed Motion

SORO NC should write a Letter to City Council President Herb Wesson and City Council Member Paul Koretz (CC'ing City of Los Angeles/ Dept. Public Works Bureau of Street Services/ Engineering Division) requesting them to have City Council initiate a study on updating to the LA City Municipal Code sections regulating of Residential Parkways to reflect recent and ongoing Safety Concerns.
