

**Great Streets:** Doug Fitzsimmons – **Update:** City came out to begin painting. However, it was discovered that the project would require losing 14 parking spaces which is 11 more than was previously discussed. Projected halted until correct amount of parking spaces was re-negotiated to 1/2. Project will renew again in November and concrete pour in late spring.
