

Thomas did not get a majority.
Run-off vote between top two, Ellen and Thomas.

Thomas Eliopoulos – 15, Ellen Lanet, - 3. Thomas is the new At-Large Representative

## VII. Unfinished Business

 a. Motion to file a community impact statement on proposed homesharing ordinance (Land Use / GB011917-8)
 Presented by Adam Rich – Motion recommends that the city's new proposed home sharing ordinance allow neighborhoods Councils to decide whether they want home sharing in their community or not.

Doug explained that the NC had already weighed in this issue. Adam said that he believed it was a new council file. Mike Flynn asked for the exact council file. Because he felt that Adam was incorrect that it was not a different file but the same one that had not be resolved yet.

Moved by Beth Hirsch. Seconded by Noa Zarur.

**Board debate:** Some back and forth about whether this was realistic for the city to regulate a patchwork of different regulations. I was determined that is was the same council file, but our last CIS had somehow dropped off.

Marj Safinia propose amendment striking points 1, 2, revising 3 to 100% of funds raised for taxes would go to enforcement. Keep 4. Strike 5, keep 6.

- Vote on Amendment: Y 9, N 9 N, A 1. Motion Fails.
- Vote: Y 3, N 15, A 1.

Doug Fitzsimmons promised to look into getting the previous CIS reinstated back to the Council file.

  Extensive questions and debate about whether paper advertising is cost efficient. Jon Liberman felt that Microsoft should foot the whole bill. Beth explained that in kind they were giving a lot more than us.
  And that without paper advertising we would be difficult to reach people that were not on the computer.

#### **Bifurcated Amendments:**

- There should be some accommodation that public polling be equitable to all and not favor one candidate.
