

III. General Public Comment

- Rob Kadota from Marvista NC Graciously came to visit, congratulate and pay respects to our new board members.

- Michoel Bloom announces special safety fair being put on by Hatzolah on Sunday June 26, 2016.
- Marj expressed condolences on behalf of the Board for the recent passing of Boardmember Kimber Smith's father.

IV. Community Reports

LAPD Report. SLO Mario Gonzales -

- Crime is down in our area about 25%.
- Report that many residents are using new security product Ring Doorbell Security Camera system that he feels is helping deter crime and identify potential suspects. He encourages security surveillance of any kind as a helpful tool





- Attempted robbery at Kincardine, 2 suspects jumped out of a car and attacked a woman and attempted to take her backpack. No leads.
- Car breakins are up. Encourages residents to lock their cars and not leave valuables in the car. 25% of car thefts and burglaries had keys in the car
- Encouraged people to pay attention when they are walking around. Should go outside on a regular basis and show a presence in the neighborhood.
 People walking around and being seen is a crime deterrent.
- Continuing patrol of parks and making arrests for gang activity and narcotics
- Reaching out through PATH to the homeless. Because of recent lawsuits, it's not permissible for the LAPD to remove or arrest homeless for sleeping on the street
- Asked community to please keep reporting suspicious behavior and to be patient with wait times.

Office of Councilmember Koretz. Doug read an update from Joseph Galloway

- There is an approved installation of a stop sign at Bedford and Cashio
- A community Q and A with head of planning Department will be held at Cheviot Hills Recreation Center, 7pm on June 27th topics will include information on BMOs, Community Plans, Re-Code LA.
