

Nomination of liaison to Palms Emergency Preparedness Committee (PEPC) (Public Safety / GB011515-4)

- Terry announced that there was another 30,000 grant from EMO that is available to all NC to apply. Suggestion made that we apply.

#### VII. New Business

a. Motion to oppose a blanket application of the proposed residential development interim control ordinance (Gres / GB011515-5)





- Kevin Gres –presentation, Send mailer to get 66% of support of each neighborhood in CD 5 before implementing ICO in that neighborhood. Let each neighborhood decide for themselves if they want those restrictions.
- Liz Carlin responded briefly regarding the origins of the proposed ordinance to do an 18 month moratorium to prevent developers from using loopholes in the current zoning laws i.e, greening and ecofriendly designs that allow them to side step the current mansionization laws and build larger homes on small lots or homes that are out of character for the neighborhood.
- Lengthy public comment and debate from members of the Beverlywood community and local developers who are against the moratorium. They feel that the Beverlywood HOA's restriction on house size and character are enough and that they want to go ahead with any plans they already have to expand on their properties according to their family and community needs. Would like an opportunity to have a public forum to discuss the issue further.
- 1st Amendment to Proposal by Terry Gomes The motion should include letters to Councilmen, Koretz, Bonin, Wesson (cc: all the Councilmen) and the following added to the Motion to read "Further SORONC believes there should be a 6 month hold on the implementation of the ICO while the city solicits community input. SORO believes that each community should have the power to decide its own future in this matter and no community should be asked to follow a vocal minority no matter which side they fall on." Motion seconded.
- Debate: Discussion about mailers not being the best way to solicit public input.
- Amendment passes by consent.
- Further debate: Discussion of presenting forums on the ICO and Mansionization issues.
- New amendment to strike the paragraph about specific mailers and 66% of community input.
- o Amendment passes by consent.

- Motion to fund \$1623.01 for the purchase (or \$450 for the Rental) of two (2) 20x20 tents or canopies and to sponsor the Emergency Preparedness and Safety Expo at SOROFEST 2015 (Lynn / GB011515-6)
  - Mike presents Motion on behalf of Public Safety: In order to increase the profile of the expo and be able to include more safety and EP organizations
  - Rent vs Own purchase tents best if approved, then the NC owns its own tents for future events.
  - Moved and seconded
  - with the friendly amendment to strike the rental clause.
  - Amendment passes with consent.
