SORO hereby authorizes sending letters to all City Council members reflecting the sentiment of this motion and community impact statements be filed on its behalf. "

VIII. New Business

Motion to approve keyholders for SORO NC mailbox and storage (Fitzsimmons / GB021915-2) (moved from Consent Agenda)

Terry explained that Mailbox Shop can only give out two keys. Can't duplicate keys. The only mail that comes in is for LUED Committee and Executive Committee. Storage unit is complicated as well.

Moved and Seconded to amend motion: Will read: President and Chair or Vice Chair of the Land Use Committee will hold the two mailbox keys. **Storage facility**: Some discussion about difficulty to get into, tabled till we get more information.

Moved and seconded: Vote passes by consent.

a. Motion to spend \$2600 to trim & maintain 17 Chinese Elm trees planted by SORO along S. Robertson Blvd. (Green Team / GB021915-6) Moved and Seconded.

Paula – explained that the trees we planted need immediate trimming. Terry expressed concern about spending the money on this right now as some of the businesses have been cutting the trees down without permission. Wants to make sure the city is going to support our plantings before spending money on maintenance. Paula explained that trimming is urgent and she has gotten special permits and doesn't want to go thru that again.

Vote: Y - 8, N - 1, A - 7

b. Motion to spend up to \$340 to buy and replace Hamilton High Garden equipment (Waxman / GB021915-7)

Paula- explained that some of the equipment has been broken and garden needs netting.

Moved and seconded.

Vote: Y = 9, N = 0, A = 7. Motion passes.

c. Motion to approve a \$3952 Neighborhood Purposes Grant for the Fresh Fruit on Fridays program at Shenandoah Elementary (Levine / GB021915-8)

Barry - Fresh fruits and Healthy foods educational program for under privileged students at Shenandoah ES. **Moved and seconded.**

Vote: Y - 9, N - O, A – 7. Motions passes.

d. Motion for \$1750 to sponsor CPR/AED/First Aid classes for SORO (Lynn / GB021915-9)

Mike: Same as last three years. Reduced CPR training for the community. Very successful last year.





Moved and seconded.

Vote: Y - 9, N - 9, A - 7. Motion passes.

e. Participation Diversification Act: Motion to require each Boardmember to propose one Neighborhood Purposes Grant and one general motion per year (Gres / GB021915-10)

Kevin - Attempting to encourage participation and incentive to inactive board members. Asking SORO board in addition to attendance requirements to also set a minimum standard of requirement of 1 NPG's and 1 Motion from each board member per fiscal year or be thrown off the board by vote of the Executive Committee.

Moved and seconded.

Board debate. Overall feeling that it was a negative way to get participation.

- Marj proposed amendments 1. That attendance should be included the board meeting Agenda packages. 2. Not practical to ask 24 board members to come up with an NPG. May not be enough organizations to cover this requirement be removed should be by board approval, not executive approval as this not the purpose of the executive committee to lord over the board.
- Amendment moved and seconded.
- Vote of the 1st amendment Y 14, N 2, A 0
- Bette commented that perhaps a committee be formed to come up with some good ideas to address the lack of participation.
- Terry moved to amend that the motion be split into 2 motions. First Motion would be that attendance would be posted on the website and that a board members attendance should be a transparency issue. **Moved and seconded.**
- Vote to split into two motions: Y 14, N 1, A 1 Motion to amend passes.
- The 2nd motion should be that **Kevin's Motion**, (as amended) should be postponed until such time as the bylaws committee can meet, review it and come up with specific language with in 60 days. Doug will reopen the rolls so that if someone wants to join the Bylaws committee they can do so in order to contribute and vote on this Motion.
- Moved and seconded. .
- Motion vote 2nd half: 16-Y, 0-N, 0-A. Motion approved.
