

General Board Meeting Minutes

Call to Order and Roll Call

SORO NC Board President Doug Fitzsimmons called the meeting to order at 7:15.

II. General Public Comment

Frank Bart - representing a small lot subdivision project on National and Robertson. Did not get on the agenda this month so he presented his project in Public Comment to let us know they had addressed landscaping, front stoop adjustments and parking issues brought up in previous LUED Committee meetings. Public hearing on the project scheduled for July 15.

Michael Thomas – Announced Swift Games Weekend Warrior project at Robertson Rec CenterJuly 25.

Barry Levine – JMB sold their Century City project.

III. Community Reports

Office of Council President Wesson. Carlin - Congrats to the NC on the successful SORO Festival. Announced the new Spring Newsletter "Eye on the 10th" put out by Council President Herb Wesson's office. Doug Fitzsimmons thanked the Councilman's office for their hard work and support during the festival and every year.

Office of Councilmember Koretz – Galloway – Congrats to the NC on the SORO Festival. Announced two new motions introduced by the Councilman

- File 15-072 asking the Dept of Housing and Community Investment, Dept of City planning and the Dept of Building and Safety to study the impact of small lot subdivisions on rent controlled housing.
- **File 14-0268-88**, a motion to review The City's Rent Stabilization Ordinance and how the city regulates implementation of the Ellis Act.

Asked for NC's to support these two motions. Announced various community events in June.

Office of Assemblymember Bloom. Cohen – State budget highlights – increased funding for early childhood education and higher education.





Announced they are hosting a School Supplies drive for low income families in the Hollywood area on July 16th.

Terry Gomes asked about a series of Bills that are making their way through the Assembly that remove local control over local issues such as cell towers placement and parking requirements for SB1818. Cohen - stated that Assemblymember Bloom is aware and the watching these bills. Will get back to the NC with more details.

Office of Assemblymember Ridley-Thomas. Scott Malsin – Congrats on SORO Fest. Bills to watch from the Assemblyman

- AB446- wants support of indefinite extension of the Baldwin Hills Conservancy Act
- AB1299, transfer responsibility of Health services for foster youth from the county they entered the system to the county where they actually live.
- Bill on Fairness in the workplace, no forced overtime for state employees.

Doug Fitzsimmons – questions for both Bloom and Ridley Thomas regarding their views on the bills in the Assembly regarding Medical Marijuana. How do they plan to vote? Both will get back to the NC.

 - Board discussion and questions about where the 10 million budget was coming from. Scott Malsin reported that it was an accumulative number from various sources and the budget for the running of the park was only a half million. All funds for programs and projects were coming from grants and various federal and state sources and not from the general fund. Doug mentioned concerns the NC had about language in a briefing document that came out of the Assemblymember's office that referenced that the amount of park space was demographed by how many African American and Latino neighborhoods were in the region and was that an appropriate way to determine if an area needed more park space? Is there a need for more expansion of that park?
 - S. Malsin said that the demographic information had been changed to reflect that there was, in general, a lack of park space and services in the region





and an overall need for improvements and expansions to meet Federal, State and local standards.

Terry mentioned public safety issues at the park, jay walking, lack of oversite of personal trainers using the park for business, blocking the use of stairs from other park goers. Giovanni mentioned concerns about needing increased parking.

Malsin said he would look into it.
