Arborist met to look at and discuss the trees that ring Robertson Rec Center. The trees do not meet the qualification of being California Native species. The City is not obligated to protect them. But, because of age and significance of the trees to the community, SORO NC is requesting that they observe those rules anyway (including, inspections and penalties for not following rules of handling) and to further protect the tree. The NC would suggest giving the trees Los Angeles Heritage Tree status.

-Continued – Senator Holly Mitchell arrived at 7:57pm

State Senator Holly Mitchell -

Meeting with all the Neighborhood Councils in the District In order to help track issues that are relevant, neighborhood by neighborhood.

Questions from the board for Holly included: Medical marijuana, affordable housing and homelessness, budgetary issues, education, school safety, gridlocked and underfunded court system, help for the middle class, fracking





and other environmental issues. Affordable Healthcare for everyone. Drought relief and funding.

Senator Mitchell said she is introducing a bill modeled after the Utah plan and she is working to identify money in the state budget that could be redirected to help cities find permanent housing and temporary measures for the homeless. Also tackling funding for poverty, housing affordability, increased training for peace officers on how to deal with the mentally ill, government transparency, help for kids in the foster care system. Getting water bonds on the ballot.

b. Motion to reconsider a Conditional Use Permit application for Alcohol Beverages (CUB) and change of hours of operation at Smart and Final located at 1835 S. La Cienega Blvd (Gomes / GB121715-7)

S &F is Moving from location to the next in the same shopping center have to reconsider their original CUB and changing hours of operation to one hour later. Board felt the community may not have had enough time to weigh in on the changes. Felt S& F needed to do more to inform the community.

This may be affecting the character of the neighborhood. Want NC to support an overlay to protect the historical houses.
