III. Community Reports

LA Police Department (Ballesteros & Gonzalez)

Crime is down. 13.8% decrease. Buglaries 38% decrease. Grand Auto Theft 25% increase. Make sure your car is empty. Less likely it will be broken in.

Office of Council President Wesson (Carlin)

Lego Movie in the park on Saturday night. Need volunteers to help out. They will be there at 10 a.m. Kevin G. asked about changing time for Sunday and Carlin responded that they changed it to Saturday night for this neighborhood after sundown. If SORO wants, they can make motion or pursue other days in the future.

Office of Assemblymember Bloom (Kurpies)

Bill passing to allow pharmacists to proscribe opiates. 2011 Bonds Bill- 6 month period-redevelopment funds. Vote in Senate. Microbeads in cosmetics didn't pass in Senate.

Office of State Senator Lieu (Turner)

AB22-Senate floor. Vote is imminent. Senator Lieu will rally for AB1839 and 400 Million for TV and Film production. August 14. ABC. City Attorney and Community Leaders review alcohol related conditions. Let Terry know what conditions SORO wants. Other neighborhoods limit Happy Hours because HH increase alcohol poisoning among young people. If you have a complaint re: Alcohol conditions at an establishment a person needs to send a formal complaint to ABC, go to the planning department and file the complaint, and go to police office and write a report to document the issue. CUB- Renewed. Question re: what a violation would look like. After Labor Day meeting the Alcohol Board will bring forward amendments about licenses that came out before the conditions went into place.

Handicap Placard Users: very interested in crafting legislation about use, possibly modeled after Illinois Bill.
