

General Board Meeting Minutes

Thursday, July 18, 2013, 7:00pm Simon Wiesenthal Center, 3rd Floor 1399 S. Roxbury Dr., Los Angeles, CA 90035 (Pico and Roxbury)

I. Call to Order & Roll Call

SORO Board President, Doug Fitzsimmons, called the meeting to order at 7:12 PM.

Board Members Absent (8): Kevin Gres, Kimber Smith, Robyn Braun, Bethie Kohanbash, David Mattis, Barry Levine, Marj Safinia and Martin Epstein.

II. General Public Comment

IV. Community Reports

- a. LA Police Department (Ballesteros & Gonzalez)
 - Officers unable to come to meeting due to other assignments.
- b. Office of Council President Wesson (Carlin)
 - Camp Council President Wesson has a camp for inner city kids this weekend.
 - Movies in the Park Council President will be hosting the Movies in the Park at Reynire Park on Friday August 2nd at dusk.
 - Newsletter Liz Carlin handed out CD10 newsletters.
 - SORO Festival Liz thanked the NC members and community for a great SORO Festival.
- c. Office of Councilmember Koretz (Bradkin)
 - City Council on recess. They will be discussing the mural ordinance next month.
 - Tania recently completed training on how to deal with homeless issues.
 - Working with stakeholders on issues regarding Caste Heights, Rob Rec Center, tree planting and a Preferred Parking District zone.
- d. Office of Assemblymember Bloom (Cohen)
 - Assemblymember Bloom's office is working on securing a national guard for the SORO safety event in October.

 - Working on two higher education bills SP173 –introduced by Senator Liu and passed the senate and SB520 which is a bill regarding online courses and also has passed the senate to be reviewed by the assembly.

- a. Confirmation of Board committee memberships and absence requests (GB071813-2)
 - Grant Cohen requested to be added to the Public Safety and Education committee.
 - Marj Safinia has requested approval for her to be absent In July and August due to travel (requested via Doug Fitzsimmons)
 - All committee additions were unanimously approved by general consensus. (14 board members voted)
- b. President's report
 - Doug announced that there would be another board retreat to discuss the "big idea" on Sunday July 21st from 1 – 4 PM.
 - There was some conversation whether or not there would be any items for the Board meeting in August. Public Safety will have a motion so there will be a meeting.
- c. Treasurer's report and approval of monthly expenses (Gomes / GB071813-3)
 - Since there have not been any expenses in the past month, there were no expenses to approve.
 - Financial training requirements all board members need to complete the financial training – either online or in person – in order to be able to vote on funding motions

VII. Unfinished Business

- Motion to support a height variance at 1500 S Beverly Drive (Land Use / GB052013-7)
 - Property is located at corner of Beverly Dr and Cashio sidewalk higher on Beverly – driveway off Cashio using rear yard for driveway – open space on roof – to be ADA compliant they are requesting 10% extra height for elevator. Lavish landscape. Proposing 8-units with 1 low income. 3 bedroom units. Mediterranean style.
 - Amendment proposed to restrict roof access hours did not receive a second.
 - iii. Motion to approve the height variance request at 1500 S. Beverly Drive and send letter of support to La City Zoning Administrator
 - Doug Fitzsimmons moved the motion and it was seconded by Michael Lynn.
 - Motion was approved by the board.
- b. Vote Count was: (14 YES/0 NO/0 Abstain).

VIII. New Business

- a. Motion to support the suspension and re-evaluation of DWP's FIT-100 program (Gomes / GB071813-10)
 - After hearing from a representative from DWP and hearing about a position from the Rate Payer Advocate Dr. Fred Pickel, a motion was presented to postpone the motion.
 - Jon Liberman moved the motion and it was seconded by Paula Waxman.
 - Motion to postpone was approved by the board.
 - Vote Count was: (13 YES/1 NO/0 Abstain).
- Motion to fund up to \$500 for Informational Community Gatherings (Smith / GB071813-4)





AMENDMENT – That SORO NC allocate *up to \$100 per event* to produce and market informational community gatherings in various SORO neighborhoods.

- Victor Mitry moved the motion and it was seconded by Jon Liberman.
- Motion was NOT approved by the board.
- Vote Count was: (6 YES/8 NO/0 Abstain).

MOTION - That SORO NC allocate up to \$500 to produce and market one or more informational community gatherings in various SORO neighborhoods.

- Doug Fitzsimmons moved the motion and it was seconded by Beth Ryan.
- Motion was approved by the board.
- Vote Count was: (12 YES/2 NO/0 Abstain).
- c. Motion to support retaining Grayce Liu as General Manager of the Department of Neighborhood Empowerment (Fitzsimmons / GB071813-5)
 - Doug Fitzsimmons moved the motion and it was seconded by Beth Ryan.
 - Motion was approved by general consensus with 14 board members in attendance.
- d. Motion for \$800 to fund the purchase of office and printing supplies (Fitzsimmons / GB071813-6)
 - Doug Fitzsimmons moved the motion and it was seconded by Michael Lynn.
 - Motion was unanimously approved by the board.
 - Vote Count was: (14 YES/0 NO/0 Abstain).
- e. Motion to support Councilmember Huizar's full resolution (12-1682-S1) to modify the "Plan for a Citywide System of Neighborhood Councils" and supporting administrative code changes to remove the existing factual basis stakeholder definition for NCs and substitute one for community interest stakeholders. And to authorize a community impact statement and public testimony to that effect. (Fitzsimmons / GB071813-7) SUBSTITUTE MOTION: To reject this motion and to replace it with the language that we already approved regarding at-large stakeholders which allows each NC can adopt their own definition and number of at-large seats for that neighborhood council.
 - Jon Liberman moved the motion and it was seconded by Doug Fitzsimmons.
 - Motion was approved by the board.
 - Vote Count was: (13 YES/0 NO/1 Abstain).
- f. Motion to support the initial recommendations of the NC Plan Review committees (Fitzsimmons / GB071813-8)
- Motion was withdrawn.
- g. Motion to approve changes to the LA Neighborhood Council Coalition bylaws (Gomes / GB071813-9)
- Motion was postponed.
