

Special Board Meeting Minutes

I. Call to Order and Roll Call

II. General Public Comment

Doug thanked the Board members in attendance. The General Board meeting of August 18th did not meet quorum, so all items on that agenda will be carried over to the next meeting. However, the election funding motion to be considered is pressing: our election cycle has officially begun.

Doug also said that a binder containing the NC's bylaws, standing rules, the Brown Act, and City Attorney opinions would be available for public inspection at all future Board meetings.

III. New Business

Victor expressed concern about the mid-range laser printer, saying that his business has found them to be unreliable. Doug said the NC's monthly usage should fall comfortably below the recommended monthly maximum. Doug also broke down per page and yearly costs for printing. The Board expressed interest in printing agendas in B/W and two pages per side.
