I. Call to Order & Roll Call

- c. Financial report & approval of monthly expenses (Gomes / GB122012-18)
 - In order to get the motions paid for in the fiscal year, all funding motions should be to the board and approved no later than the March meeting.
 - Terrence went over the P-card charges indicating that there were no changes from the normal monthly charges for storage, sprint, vonage and e-fax.
 - Board voted to approve the financials by general consensus.

d. Standing committees

- i. Transportation no meeting nothing to report.
- ii. Education Barry indicated that Canfield Elementary school wants fresh fruit along with Shenandoah Elementary. There will be a mock court at Shenandoah.
- iii. Green Paula discussed taking the Metro line downtown and suggested a field trip for the SORO board.
- iv. Land Use Terrence discussed the Adas Torah location variances requested. This will be discussed along with the cell phone tower substation at their next meeting.
- Public Safety Mike Lynn discussed the many projects being handled by the committee including; testing ham radios, emergency preparedness, pedestrian safety, self-defense training, safe passages and SORO NC window signs.
- vi. Outreach In the absence of Marj and Kimber, Beth discussed the Town Hall that took place on December 6th. She indicated that there would be follow-up meetings with SORO residents every few months to allow them to stay connected with their neighbors.

i. Beth Ryan and Doug Fitzsimmons discussed the upcoming new board training. The date that most of the board members could attend was Sunday, January 13th although some of the presenters indicated that they would not be available. It was agreed that Beth would send out an e-mail to the entire board with more details.

VII. New Business (30 minutes)

- a. Motion to consider support for a proposed cellular substation at 1830 S. Robertson (Gomes / GB122012-19)
 - i. Veronica from Metro PCS presented her report for the cell towers to be erected on the roof at 1830 S. Robertson. She discussed their efforts to find a location suitable, other locations of cell towers, timeline for project, cost of project, renewing contract options, etc.
 - ii. Several members of the community spoke opposing the location of the cell phone towers – including a mother of three kids who lives in the community and is concerned by the toxicity and health hazards of the towers.
 - iii. Michal Rogson shared that they had received 200 signatures from community members opposing the cell tower project. She discussed how congested the traffic was at that intersection and that the alley was already tight. She indicated that three local real estate agents have written letters regarding real estate prices decreasing.

- iv. Grey Blavin also spoke opposing the cell phone towers that would be erected directly across the street from them blocking their view and potentially causing harm to their daughter.
- v. Doug Fitzsimmons read two letters that had been sent to him by community members opposing the cell phone towers.
 - The board voted to have the Land Use Committee vote on this issue and bring it back to the General Board meeting in January. (Y-12/N-5/A-0)
- b. Motion for \$3000 to purchase emergency equipment and supplies (Lynn / GB122012-20)
 - Mike Lynn discussed the items the committee would be buying to make sure that the committee had enough equipment for the training and also to have supplies for the triage team in case we do experience a crisis.
 - Board voted to approve \$3,000 (Y-11/N-5/A-1)
- c. Motion to allocate up to \$400 to fund 2012 NC vote-by-mail (Exec / GB122012-21)
 - i. Doug Fitzsimmons indicated that there was an additional cost associated with vote-by-mail that the board needed to vote on.
 - Board voted to approve up to \$400 (Y-16/N-0/A-1)
- Motion to support Grayce Liu's appointment as General Manager of the Department of Neighborhood Empowerment (Exec / GB122012-22)
 - i. Doug Fitzsimmons shared that the Mayor has sent a letter in support of Grayce Liu being the permanent General Manager. The issue will now go before the City Council. SORO wanted to add our support for Ms. Liu.
 - Board voted unanimously to support Grayce Liu as the permanent General Manager for Department of Neighborhood Empowerment. (Y-16/N-0/A-1)
