Motion to support small-lot development at 2008 Preuss (Mitry / GB121511-10) The property owners spoke in support of the measure.

- Vote: 13-Y, 0-N, 1-A. Motion passes

Motion to support Pressman Academy expansion with proposed mitigations (Gomes / GB121511-11)

Barry joins the meeting. Doug announced that Hamilton Campus Police had mistakenly turned an unknown number of people away at the gate. Extensive testimony from representatives of the Pressman Academy and opposing neighborhood groups. Speaker cards filled out were 7 opposed to the expansion, 4 in favor.

- Table vote: 7-Y, 9-N, 0-A. Motion to table fails

Doug proposes substitute language:

To formally support the proposed Pressman Academy expansion project with the understanding that mitigation discussions (as reflected in the attached Proposed Neighborhood Protection Plan) continue between Temple Beth Am, Pressman Academy, and the neighbors of the 1000 block of South Corning Street.

- Substitute motion vote: 11-Y, 4-N, 1-R. Motion passes
