i. Council File 22-0002-S113, SB 918 (Portantino) / Carry Concealed Weapon Permit / Sensitive Locations Prohibition / Psychological Testing / Cost Recovery: Introduced on August 9, 2022 and referred to Rules, Elections, and Intergovernmental Relations Committee. Resolution is requesting that the City of Los Angeles include in its 2021-2022 State Legislative Program SUPPORT for SB 918 if AMENDED (i) to permit full cost recovery for processing of license applications and psychological testing, (ii) to state explicitly that local governments may adopt additional restrictions on the allowable activities of a CCW permit holder beyond those specified in the bill,

and (iii) to amend Section 26205 of the Penal Code to require a local licensing authority to give written notice indicating whether an application is approved or denied within "a reasonable amount of time" rather than setting an arbitrary time limit.
