Re: URGENT Fast Track Permits for Bollards with Bureau of Engineering

Dear Councilwoman Yaroslavsky and Councilwoman Hutt,

The Jewish Community is facing a much higher threat level than ever before. They need to be able to protect their institutions and businesses from car ramming attacks.

The process for permits from the Department of Enineering for safety bollards to be approved and installed is too long and complex.

The SORO NC would like your office to follow up on the Fast Track Permit Application process for Bollards to be installed on the sidewalks in front of sensitive locations such as Houses of Worship, Religious Schools and other vulnerable locations.

The prior Councilman and his staff had been working with the Department of Engineering on a "Fast Track Permit Application" that had three specific types of preapproved bollards that could be installed.

We would appreciate it if you would please inquire what the current status of this "Fast Track Permit Application" and information on how a House of Worship, Religious School and other sensitive locations can obtain a "Fast Track Permit".

The current war in Israel, the rise in antisemitism and the high incidents of car ramming attacks necessitates a process whereby a permit to install bollards takes as short a time as possible and that the process is as simple as possible.

This would be a benefit not only to Council District 5 and Council District 10 stakeholders but the entire City of Los Angeles Faith based institutions.



## Motion to send a letter to CD#5 requesting the transfer of city owned property adjacent to Irving Schacter Park to the Department of Recreation and Parks for recreational use

## **Background**

Over thirty years ago land in Beverlywood was bought by the City of Los Angeles. The southern portion of this property became Irving Schacter Park which is a "Nanny" Park in Beverlywood. The Northern portion of the land was left undeveloped for future expansion as needed. Over time this undeveloped property was left uncared for and became overgrown with vegetation. The City has cleaned it up once, but it needs additional cleanup now. CD # 5 has arranged for this cleanup.

Two years ago, neighbors in Beverlywood and Castle Heights were unhappy about the condition of this parcel. A council file was requested by CD#5 (Koretz) asking for a review by the City Attorney with the purpose of declaring the property surplus and putting it up for sale. This was opposed by this neighborhood council on the basis that this land was originally acquired for recreational purposes and should be used for recreational use. We felt that it was better public policy to retain property that has inherent value and for which there is a foreseeable need. There are few open spaces in all of Soro that can be used for recreation. This specific property is small, and it is unlikely that it could be economically developed commercially. However, it could be used for a myriad of recreational purposes. Amongst them are:

- 1. Expansion of Irving Schacter Park.
- 2. A small specialty park like Holmby Hills which has an extremely small pitch and putt golf course.
- 3. Keep the property in its natural condition, clean it up, add a few benches and have a nature center and meditation park.
- 4. A skateboard park.
- 5. A Dog Park.

Any and all of these options should be considered prior to even contemplating the sale of this property. It needs to be understood by the City that any property that is required in the future will have to be purchased at current market rates. Here we have property that was purchased decades ago at a relatively inexpensive cost as compared to what the cost to replace this land would be at today's market rates.

With the retirement of Paul Koretz and the election of Katy Yaroslavsky as Council Woman, we approached CD #5 to revisit the issue. They have agreed to clean up





the property so that it will no longer be overgrown. They concur with our vision that this small property should be used for recreation. CD #5 has had preliminary discussions with the Department of Recreation and Parks. They are willing to continue discussions with the Department of Recreation and Parks subject to this neighborhood council providing a letter requesting that this land be used for recreational purposes.

## **Proposed Motion**

The South Robertson Neighborhoods Council at a duly authorized General Board Meeting asks that the following letter be submitted to the Los Angeles City Council Office #5 requesting that the city owned property immediately adjacent to Irving Schacter Park be transferred to the Department of Recreation and Parks for recreational use.

This property would be developed at little or no cost to the city. The Department of Recreation and Parks will provide visual examples as to the types of recreational uses the land might be used for. Soro Stakeholders will have input as to the preferred use for the property at a scoping meeting to be hosted by CD#5, the Department of Recreation and Parks and Soro NC. Among the options to be considered are:

- 1. Expansion of Irving Schacter Park.
- 2. A small specialty park like Holmby Hills which has an extremely small pitch and putt golf course.
- 3. Keep the property in its natural condition, clean it up, add a few benches and have a nature center and meditation park.
- 4. A skateboard park.
- 5. A Dog Park.

Once the property is transferred to the Department of Recreation and Parks, they will be responsible for the maintenance of the land.



## Dear Councilwoman Yaroslavsky:

At our regularly scheduled October 19, 2023 the South Robertson Neighborhoods Council General Board voted , by a vote of \_\_\_Yes , \_\_\_ No , to send this letter to you. The property immediately adjacent to Irving Schacter Park was acquired by the City of Los Angeles for the purpose of future recreational use by the city. The city acquired this property more than 30 years ago. It has been poorly maintained by the city resulting in the need for one major cleanup several years ago. It is currently in need of another major cleanup which has been scheduled and will be paid for by your office. We thank you for this clean up.

For the past two years this neighborhood council has requested that the land revert back to the purpose for which it was acquired. Specifically, some recreational purposes selected by the city in consultation with the stakeholders of Soro NC. Your office has listened to us and has requested this letter stating that it is the intent of this neighborhood council that the property revert to a specified recreational use approved by the stakeholders of Soro NC. As of the time that the property is transformed to its ultimate recreational use it will be transferred to the Department of Recreation and Parks who will maintain the property.

Specifically, we are requesting that the following items be undertaken:

- The Department of Recreation and Parks formalize their vision as to those uses that the land could be used for. They proceed to create visual presentations for each proposed use.
- 2. A "Scoping Meeting" be hosted by your Office, the Department of Recreation and Parks and Soro NC to allow the community input as to which alternative recreational use is preferred.
- A contract be entered into to transform the land into the selected recreational use.
- 4. The property be formally given over to the control and oversight by the Department of Recreation and Parks.
- 5. The Department of Recreation and Parks assume responsibility for maintaining the property.





We appreciate the efforts of Allen Zipper and other members of your office who have listened to our request that the land be put to its intended use and have developed an innovative solution which can be implemented at little or no cost to the City of Los Angeles,



## **Background**

Proposed By:

The Leisure Spaces Committee is one of the many committees of the South Robertson Neighborhoods Council. Many of the issues that involve Leisure Spaces have elements that involve other committees. In order to avoid overlapping issues and to better establish the scope of the Leisure Spaces Committee's concern, the committee has narrowly defined its purview and membership rules.

## **Proposed Motion**

- The South Robertson Neighborhoods Council shall adopt the following standing rule as to the purview and stakeholder membership rules for the Leisure Spaces Committee:
  - The committee's focus is on issues that are strictly related to a. Leisure activities within the Soro NC boundaries. This will include the Robertson Branch of the Public Library and those portions of the Department of Parks and Recreation that are within our boundaries. Exclusions are sanitation services, parking enforcement, and code violations. If these exclusions involve the health or safety of stakeholders using these facilities, administrators and/or employees of the facilities, or residents of property adjacent to these facilities; the Committee will share joint responsibility along with the other relevant SORO NC Committee.
  - Stakeholders are eligible to become members of the committee by b. attending at least one meeting of the Leisure Spaces Committee meetings prior to the meeting during which they request membership. They can request to become a member during the general public comment period of a committee meeting. They become a member when a vote of the committee approves their membership by a majority. Stakeholder members who have missed five meetings in a calendar year will be removed from committee membership.
  - The name of the committee shall be changed from Soro NC Parks C. & Recreation Committee to Soro NC Leisure Spaces Committee.
