

## **Approved General Meeting Minutes**

Thursday, November 18, 2010, 7:00pm Hamilton Senior High School Cafeteria 2955 S. Robertson Blvd., Los Angeles, CA 90034

#### I. Call to Order and Roll Call

SORO NC Board President Doug Fitzsimmons called the meeting to order at 7:10.

#### II. General Public Comment

In the absence of the Secretary, Martin Epstein volunteered to take notes.

Representatives from SoRo, Inc. described the long history and support they've given to the neighborhood and to the NC, including organizing and co-sponsoring the annual SORO Festival. Mary Earl proposed creating an official rep from the NC to act as non-voting liaision between the two groups.

As a neighbor in the area around the LAPD Carnival in mid-November, Howard Wolf described the serious traffic and business impact the event had on Pico and the surrounding residential streets.

#### III. Old Business

**Draft Board Meeting Minutes of October 21, 2010 (Chavarria / GB101810-1)**. Small spelling corrections only. Nick moved to approve the draft minutes, Brian seconded. **Vote: Y-13, N-0, A-1. Minutes approved.** 

Treasurer Report and vote to approve monthly expenses (Gomes / GB101810-2). Bette moved to approve the report; Brian seconded. Vote: Y-12, N-0, A-2. Report approved.

## IV. Community Reports

**LAPD Report.** Captain Nathan reported on the aftermath of a robbery on Corning St. the night before. The armed suspect barricaded himself in his home and SWAT was called in. The suspect called 911 to complain about the noise the Police were making (!). Event resolved without injury.

While not without rough edges, the \$15,000 profit from the first Pico LAPD Carnival benefited three youth programs not funded by the City. Planning began in January; many locations explored. Improving outreach seems to be key to success.

Car theft and break-ins continue to be the NC's top crimes. Advised to leave nothing in car: Hide it, Lock it, Keep it.





Office of Councilmember Wesson. Liz Carlin congratulated the NC on the Town Hall and Community Clean Up. Again running a turkey distribution program for seniors and those in need.

**Office of Councilmember Koretz.** (report given after NC reports). David Giron reported that his office will send a local shopping guide to residents in December.

Office of the Mayor. No report

**Office of Senator Price.** Rebecca Bernal reported that they are also giving away turkeys in the 21st district. Toy drive on December 9; need requests from community by December 6.

Robertson Recreation Center. No report.

### V. Committee Reports

**Executive.** Reminder that ethics training must be completed. Exec is working on emergency communication plan and goals.

**Land Use.** Halm motion tabled for this month.

**Education.** Co-operative program at Hamilton High between SORO NC and Palms NC in the works. SKATCH has 15 kids participating. New principal at Castle Heights.

**Green Team.** Spoke about plastic bag ban. Next project is e-waste reycling at Hamilton; date TBD.

**Public Safety.** Owner of Robertson Car Wash seems to be in compliance; only one OSHA complaint (against a supplier) in 40 years.

**Outreach.** Peace Picnic had in excess of 300 people. Difficulties with NC funding process, weak public funding, and food donations. Town Hall had 117 people, including 12 non-English speakers. CD10 thanked for donations of chairs, tables, and translator. Both events judged a success.

**Bylaws.** In the process of updating NC bylaws to adhere to new BONC framework.

Bette: precedents for proposed 10¢ bag charge?; Paula: still being researched.

Doug: phase bags out slowly?: Paula: targets haven't worked, problem too large.

Kimber: concerned about impact on lower income families.

Brian: file a CIS once on Council's agenda.

Michael: concerns from community, including bacteria in reusable bags, lead contamination, loss of secondary uses for disposable bags.
