SECTION II - PROJECT DESCRIPTION

4) Please describe the purpose and intent of the grant.

To assist the LAPD WLA with traffic control and pedestrian safety by purchasing a Radar Trailer and other related transportation and communication equipment to remind drivers that they need to maintain travel speeds consistent with posted speed limits. This constant reminder will be mobile and can be moved to areas of greatest current need. This will reduce traffic accidents and fatalities due to speeding within our neighborhood council boundaries. A secondary purpose is the capture of "real time" analytics that will be usefull in the deployment of motor traffic officers and the justification for implimentation of other traffic calming improvements within our neighborhood council boundaries.

- How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)
 - 1. Remind drivers of their vehicles speed in relation to the posted speed limit.
 - 2. Allow LAPD to determine the areas of greatest need for traffic control.
 - 3. Align deployment of motor traffic officers to areas of greatest need.
 - 4. Provide analytics to justify needs for additional traffic calming measures.
