Fresh Fruit on Fridays video presented by Kathy Lewis. Discussion of program .  
Kaiser originally funded \$10,000.00 for first year and then \$5,000.00 in second year. Program brings fresh fruit to Canfield Avenue School, Crescent Height Elementary School, Robertson Recreation Center and LACES as a way to introduce children to the value of fresh vegetables. Produce is brought to the La Cienega Farmers' Market on Thursday and taken to the schools for washing and distribution to the children on Friday. A brief description of the items nutritional value and background is provided to the grade level instructor who passes it on to the children. The cost to expand the program to Shenandoah Elementary School is \$6720.00 and Kathy requested SORONC fund the programs expansion.  
The committee voted unanimously 2-0 to propose to the Board that SORONC fund the expansion of Fresh Fruit on Friday at a cost of \$6720.00
