

However he was contacted by the City and told that they would remove only THREE Tipuana Tipu trees instead of the 18 being considered, and they will also fix all the sidewalks in need of repair.

IV. New Business:

a. **Climate Resolve** a climate organization would like to make a 25 minute presentation to the SORONC Board on how climate change is impacting our neighborhood together with energy and water solutions for homeowners and businesses in Los Angeles. Jason Van Over suggested that promotion for this presentation include outreach for a new Green Team Committee Chair. Barry Levine said he would make this suggestion to the Executive Committee.
