- a. **Discussion and possible action on intended project with senior daycare facility on the ground floor, subterranean and/or aboveground parking, topped with apartments or condos, possibly age restricted. The property is located at 8927-8921 W Sawyer St and is zoned C2-1VL-CPIO.**
