- a. Discussion of a Town Hall covering the committee's review of the Gibson Transportation proposal to calm traffic on Robertson Blvd. In this conversation we intend to consider both the proposal and possible alternatives. The outcome of this could lead to a recommendation to the Board for an educational Town Hall.
