# Background

The homelessness committee is one of the many committees of the South Robertson Neighborhoods Council. Many of the issues that involve homelessness have elements that involve other committees. In order to avoid overlapping issues and to better establish the scope of the homelessness committee's concern, the committee has narrowly defined its purview and membership rules.

# **Proposed Motion**

- I. The South Robertson Neighborhoods Council shall adopt the following standing rule as to the purview and stakeholder membership rules for the Homelessness Committee:
  - The committee's focus is on issues that are strictly related to a. stakeholders who are homeless, including housing and services that are exclusively for people who are homeless. Exclusions are sanitation services, parking enforcement, code violations, and safety issues.
  - Stakeholders are eligible to become members of the committee by b. attending at least one of the three most recent Homelessness committee meetings prior to the meeting during which they request membership. They can request to become a member during the general public comment period of a committee meeting. They become a member if a vote of the committee approves their membership by a majority. Stakeholder members who have missed five meetings in a row will be removed from committee membership.

Esteemed councilmembers,

Over the last several years, there was an effort to obtain trash cans for the South Robertson neighborhood. However, these trash cans are almost exclusively dispersed along Pico Blvd. According to <u>a map of Los Angeles trash cans</u>, Pico Blvd hosts nearly 4-6 public trash cans per block.

But other major thoroughfares have almost no trash cans on any blocks, save for major intersections.

We are writing to request additional trash cans be placed in areas such as Robertson & Cattaraugus around Hamilton High School, Robertson Blvd in general, LaCienega Blvd, Beverwil Blvd, Olympic Blvd, and the intersection of National and Venice.

We urge our city council districts to provide us with trash cans that the city will regularly empty. Additionally, we request solar compact trash cans in the densest areas of South Robertson such as the South Robertson business corridor and the intersection of Robertson & LaCienega.

CMs Blumenfield and Rodriguez introduced a measure that seeks to expand the Fire District 1 designation, which is unique to Los Angeles and was created more than 100 years ago. The designation severely restricts construction and building material use in specific zones. The proposed ordinance uses density as a proxy for wildfire risk, and the motion herein proposes that any neighborhood with a density above 5000 people per square mile be considered a Fire District 1 zone. Construction in Fire District 1 areas is banned from using timber, and so must rely on concrete for construction. A report by the Department of Building and Safety estimates this would increase building costs by 10.6% to 47.1% in dense neighborhoods of Los Angeles.

## **Proposed Motion**

The Westside Regional Alliance of Councils requests that the City of Los Angeles, through the Council's Government Affairs Committee, include in its Sacramento legislative priorities the following request for revisions to SB 330, and implement local regulations in conformance with such revisions, if enacted, as follows:

- 1. When RSO units are demolished and replaced pursuant to the provisions and protections in SB330, any units that must be provided pursuant to a density bonus under SB1818 or SB1222A shall be additive to those numbers of replacement units that are required pursuant to SB330 (instead of "inclusive").
- 2. All replacement units shall be of comparable size and configuration (i.e. they shall have the same number of bedrooms and at least the same square footage).

The West Pico Drill Site located at 9101 West Pico Blvd experienced a crude oil leak. The results of a state investigation revealed that the site was not in compliance with multiple safety regulations. The West LA Area Planning Commission plans to review the site's current environmental exemption in February 2022.

## **Proposed Motion**

The South Robertson Neighborhoods Council wishes to submit a statement regarding Council File 21-1025 and the West Pico drill site located at 9101 W Pico Blvd. We OPPOSE this site's California Environmental Quality Act (CEQA) Exemption considering the massive risk it has imposed on our local environment. On Saturday, December 11, 2021, a leak of approximately 15 gallons was observed in the Northern alley adjacent to the West Pico drill site. The cause was a corroded blind slip that allowed fluid to enter an out of service pipeline buried near the surface of the alley. Residents of the area reported a strong gasoline-like smell even several blocks away. This incident is a catastrophic failure of basic safety and environmental regulations. According to the California Geologic Energy Management Division (CalGEM), Pacific Coast Energy Company violated multiple state regulations regarding the maintenance of oil production facilities. The SORO NC requests a full investigation and review of this oil site in order to identify other failures to comply with safety requirements, as well as a FULL denial of the site's CEQA exemption.

#### <u>Background</u>

On Saturday, December 11, 2021 a leak of approximately 15 gallons of gross fluid was observed in the Northern alley adjacent to the West Pico Drillsite (Well Side Building). The fluid was extruding at low pressure from a joint located where the northernly side of the building wall and asphalt alley surface meet (Figure 1). The fluid was reported as mostly water with some oil. The source of the leak was determined to be a pipeline that was no longer in service, isolated through use of a "slip blind" (Figure 11-13) that failed. This pipeline was "isolated but not separated". The cause of the underground point of failure was not determined as the pipeline end is buried. Information was provided by Pat Vigeant, Senior Production Foreman of the Pacific Coast Energy Company LP.

#### Field inspection

On Monday, December 13, 2021 I arrived on site at 1100 to meet Pat Vigeant. He showed me the alley (Figures 1-5) affected while explaining the circumstances of the leak. I observed the source location of the fluid release (Figures 3, 7&8) and production facility with the failed slip blind (Figures 11-13). Mr. Vigeant used a rag and put his full body weight on the stained asphalt to show that no fluid that was released was present. I then observed the rag as dry (Figures 9&10).

We then entered the production facility where the failed slip blind and out of service portion of the pipeline that was determined to be the source of the leak was located (Figures 11-13). Inside the production facility, I observed the pipeline as having sections of pipe removed and ends capped to prevent further future releases (Figure 12).

During my visit, Mr. Vigeant stated that he does not have knowledge of the buried segment of pipe, how it was abandoned or what caused the buried segment of pipe to fail. The facts as I understand them from this visit are as follows:

- The out of service pipeline was still physically connected to the in-service, pressurized pipeline system at the time of the incident.
- The out of service pipeline was isolated by use of "slip blinds".
- The slip blind was removed and had visible corrosion and full failure of structural integrity.
- The failure of the out of service buried line, buried below the surface expression of the leak was not determined at the time of my visit.

#### Timeline of events

Saturday (12/11):

- At 2000 leak was discovered and clean up began immediately. Cleanup continued until 0100 on Sunday (12/12/21) and included absorbent material and steam cleaning.
- At 2100 facility was completely shut down for liquid operations.

Sunday (12/12)

- At 0700 crew began to isolate line.
- Removed sections of pipe to airgap pipeline.
- Added caps to the disconnected portions of the line.
- At1300 resumed operations.

Monday (12/12)

• I arrived on site at 1115 and inspected the alley and production facility.

## SPILL/INCIDENT, PACIFIC COAST ENERGY COMPANY LEASE, BEVERLY HILLS FIELD

On December 11, 2021, California Geologic Energy Management Division (CalGEM) received notification from the Office of Emergency Services (Cal OES #21-7076) regarding a spill from a Pacific Coast Energy Company LP pipeline in the Beverly Hills field. This letter itemizes violation(s) of the California Code of Regulations, title 14 (CCR).

Maintenance of Production Facilities and Equipment: CCR section 1777 (a) states, "Operators shall maintain production facilities in good condition and in a manner to prevent leakage or corrosion and to safeguard life, health, property, and natural resources."

**Out-of-Service Production Facility Requirements:** CCR section 1773.5 (a) states in part that within "six months after the determination that a production facility is Out-of-Service, the following shall be required:

(1) Out-of-Service production facilities shall have fluids, sludge, hydrocarbons, and solids removed and shall be disconnected from any pipelines and other in-service equipment.

(6) Pipelines associated with Out-of-Service tanks and pressure vessels shall be removed or flushed, filled with an inert fluid, and blinded."

**Well Site and Lease Restoration:** CCR section 1776 (f) states that "Lease restoration shall include the removal of all tanks, above-ground pipelines, debris, and other facilities and equipment. Remaining buried pipelines shall be purged of oil and filled with an inert fluid. Toxic or hazardous materials shall be removed and disposed of in accordance with Department of Toxic Substances Control requirements".

Spilled fluid and all impacted media, including surface and subsurface, must be cleaned-up. The pipeline must be abandoned to the standards specified in CCR section 1776(f). Additionally, a root cause analysis and action taken to prevent future occurrence must also be provided to CalGEM by January 11, 2022.

Pacific Coast Energy Company LP shall notify CalGEM during normal working hours (8:00 am to 5:00 pm) once the violations have been corrected for a re-inspection.

Failure to comply with the laws of California and CalGEM may result in enforcement action including, but not limited to, issuance of a civil penalty and/or order pursuant to Public Resources Code Sections 3106, 3224, 3235, 3236, and 3236.5.

## Background

As previously discussed by the SORO NC, multiple sidewalks in the neighborhood are in serious disrepair and need improvements in order to be compliant with accessibility laws. The Land Use committee previously submitted a list of specific areas where curbs especially needed modifications, in light of multiple recent lawsuits within CD-5 from pedestrians who were seriously injured as a result of broken sidewalks.

# **Proposed Motion**

Submit the below community impact statement to CF 21-1469:

The South Robertson Neighborhoods Council commends the motion in Council File 21-1469 which directs the city to develop a scope and budget for a citywide sidewalk inventory and assessment. As discussed several months ago at our general board meeting, SORO NC suffers significantly from a lack of cut curbs. In some areas of the neighborhood, more than 50% of intersections in residential areas do not have ADA accessible curbs. Our sidewalks as a whole need serious improvements in order for this neighborhood to be accessible to all who work and reside here. We hope the city will also study alternatives to removing trees from the urban canopy in cases where a sidewalk's disrepair is caused by root growth.

# Background

SORO NC bylaws require the SORO NC to hold an annual Town Hall. SORO NC voted in December to make this year's annual Town Hall dedicated to a candidate forum for those running for CD-5 City Council in the June 7, 2022 election.

SORO NC would like to provide its stakeholders the opportunity to learn more about the candidates and their positions.

To whom it may concern,

Upon review of the Project Crossings documentation and attendance at community meetings, the South Robertson Neighborhoods Council would like to express our thoughts on the development as well as welcome this development to the neighborhood.

Most importantly, Project Crossings will have a significant impact on housing within the surrounding neighborhood which falls into SORO boundaries. These areas hold significant amounts of rent-stabilized apartments, and the Council fears that Project Crossings will impact the area the same way that Sweetgreen HQ impacted its new location in Leimert Park; by driving up housing costs and incentivizing landlords to sell RSO units for re-development. We request more information on how Project Crossings, Los Angeles, and Culver City plan to soften this impact.

This project is less than 500 feet from a major Metro station, yet more than 1200 parking spots are being allocated to this office, and no plans have been announced to ensure employees of the new office utilize the Metro station. Employees working at this office are very likely to live in the surrounding areas and should be encouraged to bike, bus, or take the train to work. We simply don't have the bandwidth to safely introduce 1200 cars to the surrounding environment, which is currently optimized for cyclists, pedestrians, and public transit users. The building should include bicycle parking spots and it is the hope of the SORO NC that Apple will incentivize employees to use forms of transportation other than cars to get to work.

The plans also need improved pedestrian safety measures, such as additional crosswalks ie. on National, and at National & Washington. This area is notorious for traffic violence and any company moving here needs to do its part in improving the built environment to be as safe as possible for everyone. The drop-off station at National needs significant improvements in order to be safe for pedestrians and cyclists -- we request the project support protections to the existing bike lanes to make sure cyclist commuters are not impacted by this construction and potential deliveries once open. SORO NC strongly opposes any attempts to minimize sidewalks that already exist in this area. It is not clear from the drawings if the sidewalk or the median on Venice Blvd will remain the same size and with the same setback to be consistent with the neighboring Helms property.

Additionally, this project area is one that people go to in order to eat and shop. Project Crossings should heavily consider incorporating space for restaurants, retail, or upscale and specialty food amenities (ie. Joan's on Third or San Francisco's Falletti Foods) on the premises so that residents in the area receive new amenities that don't currently exist. Culver Studios agreed to such arrangements, and the new HBO office is built similarly with ground-floor restaurant space. We want to maintain an environment around our major Metro station that makes people want to spend time in the area even if they don't work there. The Venice Blvd side of the construction especially would benefit from more retail space. In exchange for the addition of retail, the NC would be open to supporting additional increases in height and density, or other bonuses.

The park included in the plans should be accessible to the public. We request as much accessible public green space as future employees will have, and would be willing to make other concessions in exchange for this. The new HBO office allows the public access to their parklet space, and Apple should consider the same. Any public areas for employees and members of the public would

receive strong support from the SORO NC, as a goal of ours is to see more community-oriented spaces in the vicinity. It is also the request of the SORO NC that Project Crossings reports back on potential green architecture initiatives they may implement, such as community solar on the roof, stormwater capture, and as much greenscape as possible (rather than hardscape). As a company with an innovative reputation, Apple could get much neighborhood support by showcasing these types of designs. Above all, we want to know that Project Crossings will mesh with the local community -- long time residents, low income renters, families, Metro riders, and students at Hamilton High School. Any efforts to do so will go a long way to gain the NC's support for this project.

We hope to see Project Crossings at a future SORO NC general board meeting.
