Development Policy Update

Statement:

The South Robertson Neighborhoods Council supports LA Metro's efforts to update its Joint Development Policy, and its goals to strengthen Metro's response to the regional housing crisis. Los Angeles County is facing a severe affordable housing shortage, with a pre-pandemic shortage of over 500,000 income restricted units. LA Metro is in a unique position through the Joint Development Team to leverage its position to address this with little to low additional public costs.

We support the overall goals of the policy changes, and have identified feedback on specific policy tools identified in Board File 2020-0382:

Any new policy should maintain guidelines for units reserved for households earning up to 30% AMI and 50% AMI, with units reserved for households making up to 80% AMI created as a subsequent goal. While it is admirable to ensure the development of workforce or moderate housing units, this should not come at the expense of extremely-low or very-low income units.

A per-project minimum for affordable units should be enacted, as this would ensure that projects through Los Angeles County contribute their fair share to addressing the affordable housing crisis, and provide low-income households with access to high quality transit.

Joint Development should enact a portfolio-wide goal for permanent supportive housing units reserved for those experiencing homelessness. Los Angeles County faces an acute homelessness crisis, and Joint Development is in a unique position to help address this. Utilizing Metro-owned land could leverage other state and county resources such as AHSC, IIG, and TCAC, and could be accomplished with no additional costs to Metro.

Joint Development should establish a goal for the construction of new publicly-accessible green space, either through exact square footage or as a percent of overall developed land. Los Angeles County has some of the lowest rates of public green space per capita in the country, and utilizing publicly-owned land could help alleviate this shortcoming.

We oppose potential restrictions on unsolicited proposals, as this could greatly disadvantage the development of affordable housing or permanent supportive housing by nonprofit organizations. We request that changes or restrictions to the Unsolicited Proposals Policy include an exemption for any proposal(s) that consist of either 100% affordable housing or permanent supportive housing for those experiencing homelessness.

We also welcome the Joint Development Team to present its proposed updated policy to the South Robertson Neighborhoods Council, and hope to provide additional feedback as the policy is rolled out.

The South Robertson Neighborhoods Council is concerned about the direction of the Ethic Studies Curriculum by a committee of the California Department of Education. Although we support the merits of [AB 2016](#) (1) which mandates the state's Department of Education (CDE) to develop a model ethnic studies curriculum for use in high school ethnic studies courses, we object to the labeling of Jewish American's as "white" and "racially privileged". Such claims are untrue and antisemitic and does a disservice to the ethnically diverse population of Jewish Americans. This is of profound concern to the Jewish community whom many are represented by this Neighborhood Council. While both revisions of the draft include lessons on Jewish Americans, the portrayal of the Jewish people, as filtered through the lens of Critical Ethnic Studies, clearly misrepresents Jewish Americans as the oppressor on the side of the race-class divide. Jewish Americans are a multi-ethnic people including Ashkenizim (Eastern European), Sephardim (Mediterranean, Iberia and Spanish), Mizrahim (Middle East and North Africa) and Ethiopian Jews and includes all levels of the social economic ladder with a shared Jewish history, rituals, laws, and values unifying them as an international Jewish community. The current language of the proposed curriculum is no different than the propoganda of the Third Reich. It is also disturbing to note that the list of 154 influential people of color does not include Dr. Martin Luther King Jr., John Lewis, or Supreme Court Justice Thurgood Marshall, but instead included many revolutionary figures. The Ethnic Studies Curriculum AB 2016, as written, labels Jewish American's as "white" and "racially privileged". The curriculum includes lessons on Jewish Americans that is clearly anti-Semitic and misrepresents Jewish Americans as the oppressor on the side of the race-class divide.

California is the litmus test for this country. If this Ethnic Studies Curriculum, as it is currently written, young, high school students will be indoctrinated in Jew hatred and other ideologies that embrace and legitimize brutal regimes to high school students all paid for with our tax dollars.

Los Angeles is the largest city in the state of California. Los Angeles has the ability to reject this proposed curriculum and demand a new committee be seated to come up with a new Ethnic Studies Curriculum that is what the bill was envisioned to be:

"culturally meaningful and relevant curriculum," educational standards guided by "equity, inclusiveness and universally high expectations," and an "objective of

For several years, the SORO NC has maintained a Website, an Email Marketing Platform (Mailchimp), and several Social Media accounts (NextDoor, FaceBook, Instagram, Twitter, etc...) However, there was never any definition of the administrative controls, roles, or protocols for any of the platforms. This led to confusion and/or lack of knowledge as to who was responsible for physically disseminating information on each of these platforms, often resulting in very low levels of usage.

As electronic communication and social media have evolved to become even more prevalent functions in today's society, it is important for the NC Board and Committees to use them as major outreach tools to Stakeholders.

Establishing Standing Rules for administrative roles for these platforms is the first step towards developing a Communications and Social Media Policy that is easily understood by Board Members and Stakeholders alike. A well-defined process and policy should help facilitate an increase in overall outreach.

## Proposed Motion

To Establish the following Standing Rules that define the Administrative Roles for the SORO NC Website, Mail Chimp, and Social Media Accounts:

1. The General Board shall appoint a Board Member to fill the role of Webmaster. The Webmaster shall be responsible for administering Roles and Privileges on the SORO NC Website account, in accordance with Board Guidance.
2. The Corresponding Secretary shall hold the primary responsibility for mass distribution to the Subscribed Email List (via Mailchimp), with the Outreach Chair(s) also maintaining access to the Mailchimp account, in accordance with Board Guidance.
3. The Outreach Chair(s) shall hold primary responsibility for distribution of information through SORO NC Social Media Accounts, as well as assigning additional editorial/posting roles, in accordance with Board Guidance.

Los Angeles renters are among the most rent burdened in the country. More than half of LA renters spend more than 30% of their income on rent. To make rent, people are forced to sacrifice food, medicine, and other essentials. A huge impediment to rent relief is the Costa-Hawkins Rental Housing Act of 1995, which severely limits the ability of municipalities to establish or expand rent controls. But under Costa Hawkins, LA can take a step to protect renters by adjusting the formula by which rents are allowed to increase annually for units covered by the city's Rent Stabilization Ordinance (about 600,000 rental units, more than 40% of total units and about 70% of all city rental housing).
