Background

Los Angeles renters are among the most rent burdened in the country. More than half of LA renters spend more than 30% of their income on rent. To make rent, people are forced to sacrifice food, medicine, and other essentials. A huge impediment to rent relief is the Costa-Hawkins Rental Housing Act of 1995, which severely limits the ability of municipalities to establish or expand rent controls. But under Costa Hawkins, LA can take a step to protect renters by adjusting the formula by which rents are allowed to increase annually for units covered by the city's Rent Stabilization Ordinance (about 600,000 rental units, more than 40% of total units and about 70% of all city rental housing).

Background

The proposed mixed use development at 9500 W Pico Blvd is located at the intersection of Pico & Beverly. It is currently a single story car wash on a 26,000 square foot site. The applicant's goal is to create a mixed-use building that serves the neighborhood with ground floor retail and dining options, as well as five stories and 67 units of much-needed housing at a major public transit stop, including 7 affordable units in an area with a high median income and dearth of market rate housing options.

The project seeks Density Bonus exemptions and FAR, Height, and Parking Incentives. The C4-1VL-O Zone typically allows a FAR of 1.5, which was originally intended and optimized for non-residential development. The proposal is a mixed-use, mixed-income project with multifamily residential, restaurant, and retail uses.

Background

The COVID -19 Pandemic has created havoc for Los Angeles, and in particular the South Robertson area. The quickest path to restoring normalcy to the lives of our stakeholders is through vaccination. Charlie Stein and Terrence Gomes were notified of the ability for our stakeholders to be vaccinated locally. Due to the urgency, Charlie Stein authorized Terrence Gomes to outreach to the community to get stakeholders signed up for vaccinations locally. Originally the SORONC was offered 29 slots to have our Stakeholders vaccinated. Due to the demand, we were able to get 59 stakeholders vaccinated. All the stakeholders were either Phase 1 or Phase 1B eligible.

As the County of Los Angeles moves to the Severe Health Conditions Phase, the SORONC needs to work more closely with CD 5 and CD 10 to get more Stakeholders vaccinated.

Dear Councilmember Koretz and Councilmember Bonin,

We, the South Robertson Neighborhoods Council (SORONC), are writing to you about your motion, Council File 20-0841-S4 regarding the creation of tiny home villages to house the homeless in the City of Los Angeles.

In the motion, you requested that the City Administrative Officer (CAO), the Bureau of Engineering (BOE), the Department of Building and Safety, and any other relevant departments and agencies review the Pallet Shelter tiny home village program and develop alternatives which can bring the per unit cost down to the \$17,000-\$22,000 range. CAO and BOE were to report back in 30 days with recommendations for reducing costs of tiny home villages. The motion was introduced on December 15, 2020. Thirty days have long passed since the introduction and the council file has not been updated with the report.

For the SORONC to fulfil its mission under the Charter and to create a Community Impact Statement (CIS) based on factual data, we need the report back to study, review and share with our stakeholders to provide the City Council with feedback to combat the current crisis.

Given the urgency of Los Angeles' homelessness crisis, we strongly advise that you demand the report from CAO and BOE back immediately so that more of our unhoused neighbors can be provided with shelter in the City of Los Angeles in an expeditious manner.

Background

The City of Los Angeles Health Commission's purpose is to determine the health needs of the people of the City of Los Angeles, determine whether those needs are being met, and to help determine the best and most cost effective ways of meeting those needs. CD 10 and the South Robertson Neighbors Council stakeholders are not currently represented on this Commission.

In addition, <u>CF 20-0769-S2</u> directs the office of the Chief Legislative Analyst (CLA) and the office of the City Administrative Officer (CAO), with the assistance of the Housing and Community Investment Department (HCID), and all relevant City departments, to review the delivery of health, mental health, and social services by the County of Los Angeles, to the over 41,000 unsheltered residents within the city limits, including the coordination of those services between the County, LAHSA and non-governmental partners, and report to Council with recommendations.

The Council File also requests that the Los Angeles City Health Commission, with the assistance of the CLA, CAO and City Clerk, to hold hearings focused on people experiencing homelessness and the delivery of health, mental health and social services by the County of Los Angeles, LAHSA and other non-governmental partners.

Without representation on the Los Angeles City Health Commission, the stakeholders of SORO, both housed and unhoused, will not have proper representation.

Without representation on the Commission for the people of CD 10 and our stakeholders in SORO, the Commission cannot determine the health needs, determine whether those needs are being met, and to help determine the best and most cost effective ways of meeting those needs for the residents you represent.

Our neighborhood council recommends that this position be filled by one of our Neighborhood Council Boardmembers. We suggest that





(Martin) Jon Liberman be appointed to this Board. Mr. Liberman has many qualities and years of service that will make him uniquely qualified for the position.

- 1. He is a founding Board Member of our neighborhood council. Mr. Liberman was elected to our Board in August, 2002. As we are coming up on our 20th anniversary, Mr. Liberman has been an active Board Member for over 18 years.
- 2. Prior to his retirement from the Insurance Industry, he had served more than 25 years as Manager of Underwriting and Product Development for both Individual and Group Life and Health Insurance lines of business. He has served on Industry task forces that have advised the Federal Government on how to draft the HIPPA laws. His expertise makes him well qualified to relate to the delivery of Health and Mental Health services.
- 3. Members of his family are Special Needs, so he has a unique perspective as to the needs of this subset of the unhoused population.
- 4. Over the past 20 years Mr. Liberman has had a demonstrated interest in the welfare of children educated by the Los Angeles Unified School District (LAUSD). He has been recognized as a Trailblazer by LAUSD in 2007. One of the Certificates of Appreciation he received at that time came from yourself in your position as Los Angeles County Supervisor. Mr. Liberman currently sits on the community advisory panels for the renovation of Alexander Hamilton High School and for Shenandoah Street Elementary School. This lengthy service to education makes him qualified to relate to the impact of homelessness on the ability of children to gain the life skills necessary to thrive in our complex society.
- 5. As a 76 year old retired person Mr. Liberman has served our aging population for many years.

The South Robertson Neighborhoods Council has full faith in the ability of Mr. Liberman to fulfill the requirements as a Commissioner on the Los Angeles Health Commission and to represent the housed and unhoused people of CD 10 and the SORO area.

When COVID-19 hit, Metro eliminated all fares on trains and buses in order to assist essential workers who rely on public transit and were facing wage cuts. Cutting Metro fares has made it easier for working class riders to use the bus or train for free. Fares represent a very minimal amount of Metro's income (between 5% and 15% depending on calculation) but do represent a large barrier to public transit use (fare increases have outpaced cost of living increases over the last several decades).

We, the South Robertson Neighborhoods Council, SUPPORT the motion to support and/or sponsor legislation that would provide funds to agencies to provide fare-free transit in Los Angeles. Reliable and affordable public transit supports our general economy, helps reduce car reliance, and clears our air. Transit fares are often a burden on those that can least afford it, and COVID-19 has led to service cuts at a time when people can least afford alternative transportation. Currently, Metro is considering permanent fare-free transit for its riders. Very little of Metro's operating budget actually comes from fare collection. Free Metro fare would incentivize more Angelenos to use public transit rather than cars.

Background

Bicycle thefts have become more prevalent in Los Angeles over the past few years.

The Los Angeles Police Department has partnered with Bike Index, a bicycle registry, to aid in the return of stolen bikes to their rightful owners. Bike Index is a free, non-profit bicycle registry that is available to the community and will help individuals recover their stolen or lost bicycle regardless of where it is found.

The goal of this partnership is to benefit the Los Angeles community by increasing law enforcement's ability to recover lost or stolen bicycles. Bicycle owners can voluntarily register their bikes for free with LAPD on Bike Index, and trusted law-enforcement users will be able to contact registrants when their bikes are found. Registering a bicycle with Bike Index or searching for bicycles is easy - just create a Bike Index account at www.bikeindex.org/lapd. The only information needed to add a bicycle to Bike Index is the serial number, photos and any other identifying information.

The effectiveness of this partnership could be beneficially enhanced by the City Council opening a Council File to recommend Retailers that sell bicycles to provide customers with information on the bicycle registry partnership/program.

Background

Affordable housing is maintained through regulatory rent covenants. When a new building is developed, a set amount of housing is set aside to remain affordable based in income levels – however, those restrictions only apply for several decades and eventually expire. The City is currently at risk of losing thousands of affordable housing units through the impending expiration of regulatory rent covenants. A recent UCLA report found that the lifting of eviction bans led to increased likelihood of COVID-19 deaths nationally — the lifting of moratoriums likely resulted in between 365,000 and 500,000 excess Coronavirus cases.

We, the South Robertson Neighborhoods Council, SUPPORT the motion to instruct HCID to report on recommendations for implementing an immediate rent freeze on residential units with expired or soon to be expired affordability covenants based on health and safety findings regarding undue tenant displacement during COVID-19. We encourage the city to additionally look for options to extend covenants beyond the 30-50 year range and look into options for covering rising utilities in units with covenants.

Project Roomkey is a collaborative effort by the state, county, and LAHSA to secure hotel and motel rooms for vulnerable people experiencing homelessness ie. persons over 65 or those with health risks and co-morbidities as they are especially susceptible to COVID-19 which has remained a high risk in congregate shelter settings. The program was discontinued due to city budgetary reasons. At the end of January, the Biden Administration announced that FEMA would reimburse 100% of costs associated with such programs and thus would fully subsidize hotel rooms without requiring the city to find money in its budget.
