Background

All board members are required to take and pass certain training courses required by DONE, and to sign and abide by the Department of Neighborhood Empowerment's (DONE) Code of Conduct and the SORO NC Code of Civility.

A SORO NC standing rule passed on May 21, 2015 established a requirement for all voting members of NC committees to sign and abide by the Department of Neighborhood Empowerment's (DONE) Code of Conduct and the SORO NC Code of Civility. The same standing rule requires that all committee Chairs, Co-chairs, and Vice Chairs must take all training required of the Board as mandated by DONE.

This motion simply serves as a reminder of existing responsibilities related to ethics, civility and conduct. This motion is brought as a reminder to everyone actively involved with the board and its committees, in hope of improving the workings and effectiveness of the board in addressing the interests of the SORO community.

Proposed Motion

In keeping with existing DONE and Standing Rule requirements, the Executive Committee will, through an assigned board member and before the next regularly scheduled General Board meeting, send to all board members, and to all voting members of committees who are not also board members, copies of the Department of Neighborhood Empowerment's (DONE) Code of Conduct and the SORO NC Code of Civility, and shall require that all recipients sign and return the documents prior to their next participation in a SORO meeting.

Also, in keeping with the same Standing Rule the executive committee, through an assigned board member, will ask DONE to provide training credentials to any committee Chairs, Co-chairs, and Vice Chairs who are not also board members, and said recipients shall be required to take and pass the training prior to participating in the next earliest meeting they are scheduled to attend.

Background

Cut through traffic is a constant issue within SORO, making our streets less safe and peaceful. Safe streets are all the more important during this pandemic, as many more people are walking, running, and biking our streets, and our sidewalks are not wide enough to allow people to do so while maintaining recommended social distance guidelines.

The City of Los Angeles recently implemented Slow Streets in streets near SORO, such as Palms.¹ By putting up temporary barriers at intersections asking cars to slow down and not cut through, this Slow Streets program has successfully led to many of our streets being calmer and having less cars, making them safer to walk, run, bike and scoot.²

The LA City Council has the opportunity to vote on a motion (Council File 20-0838) to make the Slow Streets program permanent. Accordingly, at least 6 other neighborhood councils have submitted to the abovementioned Council File a similar community impact statement to the one attached here.

Motion to establish standing rule regarding appointment of replacement members with ballots of more than 10 people

Background

The Bylaws state that if there are more than two candidates running for an office, if no one obtains a majority of the vote, the top two vote getters advance to a run-off. While this system may work with only a few candidates or in a city where there are millions of people voting, this system may lack justice and equity in our Neighborhood Council where there are maximum of 24 voters when replacing a councilmember.

In the upcoming election of an At-Large Representative, there are over 20 candidates. As such, it is likely that the vote will be spread among a number of parties such that including only 2 in a run-off may come as a result of only 4 potential members voting for those two candidates.

In the interest of fairness, the Executive Committee has proposed the following addition to the standing rules in circumstances where more than 10 candidates are running for an appointment as a councilmember following the resignation, withdrawal, or removal of a prior councilmember.

Proposed Motion

To add the following to the SORO NC standing rules:

1. When more than 10 candidates are applying, the first round of voting will consist of all voting members casting a vote of one candidate and any candidate receiving at least 2 votes will advance to the second round.
2. If more than 10 candidates remain, a second round vote will allow the top 3 vote getters to the 3rd round of voting. Thereafter, the procedures will continue as stated in the Bylaws whereby the top 2 vote getters advance to the final round.
3. If less than 10 candidates remain after the initial vote, only the top two vote getters will advance to the final round whereby the vote will continue as stated in the Bylaws.
4. Notwithstanding the foregoing, if one candidate obtains a majority of votes in any round, that candidate shall immediately be deemed the winner.

Background

At the beginning of 2020, Los Angeles residents were discussing the biggest crisis the city had faced in more than a decade: the homelessness crisis. Of course, the Covid-19 pandemic has dominated our conversations since March. But we are keenly aware that the current pandemic will only contribute to the number of homeless individuals in this city, the extent of which is not yet known. Senate Bill 1120 is part of a series of legislative proposals, the Senate Housing Production Package, intended to increase the construction of additional residences. SB-1120 aims to increase housing by allowing the construction of additional residential units in traditionally single-family neighborhoods. As written, SB-1120 would accomplish this through 2 changes to the rules governing single-family properties.

- Existing single-family homes can be converted into duplexes
- Existing single-family lots can be subdivided into 2 separate, fee-simple lots. A new, 2-unit building can be constructed on the newly formed lot.

SB-1120 allows for local agencies to require up to one parking spot per unit, unless the lot is located within a half mile of a "high-quality transit corridor, a major transit stop, or within one block of a car share service.

Although the Accessory Dwelling Unit (ADU) bills passed in 2017-2019 did result in the creation of additional units throughout Los Angeles, the majority of the ADUs built were in more affluent areas of LA. (Existing ADU regulations do not allow an ADU to be sold separate from the sale of the main house.)

Of all of the land zoned for residential use in the city of Los Angeles, more than 75 percent is zoned single-family. SB-1120 will not only encourage the construction of additional residential units during a time of extreme shortage, but it will also provide more opportunities for home ownership in single-family neighborhoods across LA with varying levels of economic opportunity.

Background

A recent DONE survey (Survey) explored methods to develop and support alternatives to armed crisis response. Additionally, the California Assembly passed AB-2054 "Emergency services: Community Response: Grant Program" (Assembly Bill).

The creation of a City Council file would discuss those alternatives, including revamping the City of Los Angeles 911 system. The 911 system should have a call option so that there are three options: Option 1 police, Option 2 fire/ems, and Option 3 Community Assistance Liaison Team. Option 3 would be created to meet the demands for an alternative to arm crisis response for homelessness, domestic violence, neighbor disputes, and other quality of life issues.

Proposed Motion

- I. For the SORO NC strongly urge Councilmembers Koretz and Wesson to have the City Council create a new Council File to develop and support alternatives to Armed Crisis Response, as recommended in a recent DONE survey and AB-2054, including revamping the City of Los Angeles 911 System.

Background

At the general board meeting on July 16, 2020, the board voted 15-Y, 2-N to support the tenant-notification project. This project aims to send notifications by mail to tenants of buildings that are subject to demolition or redevelopment and that come before the Land Use Committee and General Board. Because many tenants are unaware of such projects—or are made aware too late—many are not able to share their perspectives about projects that directly impact them with the committee and the board. This notification projects hopes to fill that important gap in communication.

Coordination with the Land Use Committee has been challenging because, on the most part, presenters confirm with the committee roughly a week in advance of the meeting. Additionally, service delays with the U.S. Postal Service are an issue because tenants must be notified in a timely manner, especially if letters are sent within a week's notice. As a result, the Outreach Committee, at its August 31 meeting, proposed a different solution to notify residents: Post flyers in front of subject property that will presented before the Land Use Committee as soon as the meeting agenda is posted 72 hours in advance.

This shift in communication method will require the purchase of a brochure box with a stake to hold the flyers and funding to print the flyers at a copy center. The flyer will loosely summarize the notice letter that the Outreach Committee approved at its meeting on July 27 (draft copy is attached to this motion).

- I. That SORO NC fund up to \$300 for the costs to purchase a staked brochure box and photocopying costs for the tenant-notification project.

In lieu of mailing out flyers, affected tenants will be able pick up a flyer immediately outside their residence.

U.S. mail will most like result in delays, so distributing flyers may be more effective in quickly communicating important information to tenants.

In recent meetings, tenants and stakeholders have notified us of their knowledge of presentations *after* they occurred. Providing flyers may reduce the gap in communication.

Flyers offer a redundancy to what developers are asked to send by the NC to notify tenants and others within a 500' radius.

Arguments against:

Every month, one person will be assigned to make copies and place stakes. This requires some coordination and volunteer time, which might not be available.

The brochure box might be destroyed if left out in the public for three days/72 hours.

Mailing is easier.
