Background

The United Nations' Intergovernmental Panel on Climate Change has found that rapid warming caused by climate change will cause increased droughts, wildfires, food shortages, and other ecological and humanitarian disasters far earlier than previously expected.

The same study found that a global reduction of carbon emissions of 40 to 60 percent from 2010 levels by 2030 is necessary in order to limit a rise in global temperatures above 1.5 degrees Celsius, and avoid the most catastrophic impacts of climate change.

Los Angeles' leading contribution to carbon emissions is the electricity sector representing 73% of total carbon dioxide emissions in 2017 among the waste and transportation sectors.

Community Impact Statement in support of a 100% clean, renewable energy transition for LA by 2030 Council File 16-0243

In 2017, the Los Angeles City Council passed a motion (Council File 16-0243) pointing out that fossil fuels pose a risk to our climate, recognizing the advantages of renewable energy, and initiating a 100% Renewable Energy Study.

The aim of the study is to determine what investments should be made to achieve a 100% renewable energy portfolio for the Los Angeles Department of Water and Power (LADWP), but it does not currently include any proposals for achieving 100% renewable energy by 2030, and it also allows for the continued combustion of methane, biomass, and biogas and the use of nuclear energy and renewable energy credits.

Any proposals created through the city's 100% Renewable Energy Study should include robust participation and dialogue with the public, so that community input can help guide the city's transition to a decarbonized future.

Whereas as the country's largest public utility, LADWP's leadership in transitioning Los Angeles to 100% clean renewable energy would set a powerful example for cities around the world;

Background

Revnier Village Neighborhood Association (RVNA), covering Zone 5 of the South Robertson Neighborhoods Council (SORONC), hosts an ice cream social every year in Reynier Park. The event is an opportunity to invite kids and adults alike from the area to enjoy ice cream and mingle with one another in an inviting and festive atmosphere. In previous years, the event was an opportunity to gather feedback about ways to improve Reynier Park. This year, the event is being held to encourage engagement with the community—whether they're residents of Reynier Village or otherwise—and to promote awareness of SORONC. The event is being held on Sunday, July 28, the weekend after Council District 10's annual Movies in the Park night. RVNA members will be at the Movies in the Park event to promote the event and invite attendees to take part.

In previous years, the event attracted many families that are not typically engaged in SORONC activities—save for Movies in the Park and SORO Fest. This ice cream social gives the community an event that is welcoming and is also an occasion to interact with constituents and make them aware of SORONC and how they can get more involved, whether its via signing up for the mailing list or a conversation about other events.

SORONC would cosponsor RVNA's event, with the funds going toward the purchase of ice cream and watermelon from Smart and Final (all kosher). Funds would come from the FY 2019–2020 outreach budget. The event has been sponsored in previous years at a higher amount. Additional costs for the event will be incurred by RVNA.

Background

Full Proposal

As part of an overall SORO NC Emergency Preparedness Plan and the Public Safety Committee's "Neighborhood Team Program" (NTP), it is important that stakeholders be trained in CPR, Child CPR, Automated External Defibrillator (AED), and First Aid.

In a major emergency or disaster where first responders and medical professionals may be overwhelmed, these classes would train residents to perform potentially lifesaving rescue and medical care. Training and skills could also prove critical to potentially saving someone's life during non-disaster situations. Certified instructors would demonstrate and train participants in basic first aid techniques, CPR for adults and infants, and proper use of an AED. Participants that complete the training course will obtain American Heart Association certification.

The Public Safety Committee would schedule 1 class for (up to) 25 participants each, to be scheduled for (tentatively) Sunday August 28, 2019. SORO NC would cover the costs of instruction, certification and necessary supplies.

SORO NC has previously sponsored CPR/Child CPR/First Aid/AED classes (2012. 2014, 2015, 2016, 2017 and 2018) that were very successful and highly praised. Within a month of completing a class, one of the participants was able to use his skills and assist in the saving of a life.

Proposed Motion

For the SORO NC to sponsor and fund \$2000 for the following

- a. \$1800 for 1 (one) CPR/Child CPR/AED/First Aid classes for up to 25 participants each, provided by Vital Training, and
- b. Up to \$200 for location fees, and/or flyers, and/or social media ads, and/or refreshments.

This effort by WRAC stems from an event in Pacific Palisades in April of this year where an individual was seriously injured in a hit-and-run accident caused by a dockless electric scooter user who fled the scene. After this incident, the company who operates the dockless scooter involved in the accident, was, allegedly, not forthcoming with law enforcement during the investigation of this crime.

WRAC's resolution states that, as a condition of being granted a business license or a permit to operate, companies that operate Dockless Mobility Devices in LA should be required to provide user information to law enforcement in the event of an accident involving injury as a result of the operation of their dockless scooters/bicycles.

Proposed Motion

I. That SORO NC submits a Community Impact Statement (CIS) in support of WRAC's resolution requesting changes to the City's Dockless Bike/Scooter Share Pilot Program (Council File 17-1125).

Safety should be the top priority of the companies operating Dockless Mobility Devices in LA.

[Proposed] WRAC Resolution re Dockless Electric Scooter & Bicycle Providers

Whereas, on or about April 13, 2019, the pastor of a church located in Pacific Palisades was seriously injured in a hit-and-run accident recklessly caused by the user of a dockless electric scooter, who fled the scene (on the sidewalk outside of the church rectory) and could not be immediately apprehended at the time of the accident;

Whereas, any of us in any neighborhood of the City could be victims of such future reckless and unlawful conduct;

Whereas, the business providing the dockless electric scooter involved in the above accident refused to provide information to law enforcement about the user or to reasonably assist in law enforcement's investigation of the accident, resulting in an inability to bring the user to justice or a significant delay in justice;

Whereas, in the interest of public safety, every business providing dockless electric scooters and/or bicycles (Dockless Mobility Devices) operating in the City of Los Angeles (City) should reasonably be required to cooperate fully with law enforcement under the circumstances described above as a condition of being granted a business license or Dockless Mobility Permit;

Whereas, such requirement of provider cooperation with law enforcement is necessary to protect the safety of the public and does not unreasonably infringe on the privacy rights of users of Dockless Mobility Devices;

Whereas, it is the responsibility of the Los Angeles Department of Transportation (LADOT) and the City to "promote safety... and improve the quality of life for the people of Los Angeles " (LADOT Statement);

Whereas, prominent Dockless Mobility Device providers all publicly proclaim that the safety of riders and the community is their "obsession" (<u>Bird</u>) or their "top" (<u>Lyft</u>) or "#1" (<u>Lime</u>) priority;

Whereas, Dockless Mobility Devices providers can provide notice to users in the "Terms of Use" of their rental agreements that user information will be provided to law enforcement, upon request by law enforcement, in the event of an accident involving injury to another person caused or claimed to be caused by the operation of the Dockless Mobility Device;

Now, therefore, be it

RESOLVED, that _______ NC/CC urges the City to (1) deny a business license and/or Dockless Mobility Permit, or suspend and/or revoke any previously-issued business license and/or Dockless Mobility Permit, to any provider of Dockless Mobility Devices operating in the City that fails or refuses to cooperate fully with law enforcement in providing information about the user of its Dockless Mobility Device involved in an accident causing injury to another person; (2) if and as necessary, immediately enact additional regulations amending existing rules and/or data protection policies in the City's Dockless Mobility Pilot Program to provide for issuance of business licenses and/or Dockless Mobility Permits only upon condition that providers cooperate fully with law enforcement under the circumstances set forth above; and (3) provide for suspensions, followed by revocation hearings, of any such licenses and/or permits issued to Dockless Mobility Device providers that fail or refuse to comply fully with law enforcement under the circumstances set forth above.

Background

The Land Use and Economic Development Committee met on July 9, 2019 to discuss plans for the new fiscal year. During a review of the past year it was felt that the number of land use issues was precluding adequate time that should be spent on economic development and on advocating for business development of Soro Stakeholders. The LUED Committee in recognition of the problem recommends that Economic Development be eliminated from the responsibility of the Land Use Committee and that a separate standing committee be created to focus on economic development and business advocacy.

Proposed Motion

The South Robertson Neighborhoods Council hereby amends its Standing Rules to remove "economic development" from the existing Land Use and Economic Development Committee which will hereinafter be referred to as the Land Use Committee. Concurrent with this change a new standing committee will be established which will be known as the Economic Development and Business Advocacy Committee.
