Motion to request changes to the proposed City Council mural ordinance

Full Proposal

The City's proposed MURAL ORDINANCE is expected to go to the full City Council for its consideration in July. The original intent of the ordinance was to facilitate the placement of new murals as well as protect and preserve existing murals. However, a very problematic change to the ordinance was made at the City Council's Planning and Land Use Management (PLUM) committee, which has to do with the minimum number of residential units to be allowed to display a mural.

As first proposed by the Planning Dept., murals were to have been EXCLUDED from residential properties of fewer than five units. Then at the City Planning Commission, that was reduced to a ban on residential properties of two or fewer units. Murals were to be allowed anywhere in the city EXCEPT for duplex and R1 properties.

At PLUM following discussion, instructions given to the City Attorney were to draft an ordinance with NO carve-out or exception for R1. The ordinance passed quietly out of PLUM on 1/15/13, allowing for murals to be placed on single-family homes.

If adopted as proposed this ordinance has the potential to tremendously impact residential neighborhood character. While the ordinance includes a provision that requires those planning to install an art mural on their property to do community outreach, there is no requirement to respond to, act upon or implement comments received from neighbors or the community.

Each neighborhood is different; that truth led to the creation of the NC system.

Another issue: the definition of "art." The fear is that it is so broad that it may spark lawsuits from sign companies and advertisers who might argue, say, that an artistic version of a Coke bottle qualifies. Indeed, digitally-printed images are considered "Original Art Installations" under the current version of the ordinance.

In essence, while the original intent is laudable, as currently drafted it creates a new (and poorly written) by-right planning provision. We should be extremely careful when creating new by-right categories, as we have seen time and time again within the City.

Proposed Motion

To communicate to the City that:

While the South Robertson Neighborhoods Council supports community beautification through original art murals, the current draft ordinance is overly broad and its newly-created by-right provisions would create unintended negative effects in our community. Therefore, we ask:

I. That the final ordinance include an exemption for R1 (Residential) zones and all low-density residential properties (less than 5 units), per the Planning Department's own recommendation;





- **II.** That it include provisions for individual areas/Neighborhood Councils to work with the City to establish overlay zones that would prohibit and/or require NC or Area Planning review of new mural installations;
- **III.** That the current draft ordinance not be considered for adoption by the City Council and instead be returned to PLUM for amendment, with the participation of Neighborhood Councils.

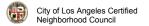

Motion to add a Neighborhood Council Member to the Executive Employee Relations Committee (EERC)

Request for Council to create a position for a Neighborhood Council Member to be part of the EERC

Full Proposal

The Executive Employee Relations Committee (the "EERC") consists of the Mayor; the President of the City Council; the President, Pro Tempore of the City Council; the Chair of the Budget and Finance Committee; and the Chair of the Personnel (and Animal Welfare) Committee.

The EERC oversees the City's labor relations; provides bargaining instructions to the City's negotiator regarding salaries, benefits, pensions, and other related matters; and makes recommendations to the City Council;

The EERC was involved in labor negotiations that resulted in salary increases that increased the Structural Deficit:

The leaders of the City's civilian unions have indicated that they are not willing to forego their 5.5% raise in January or contribute 10% of the cost of their health care plan which will result in a four year cumulative deficit of almost \$800 million; All of the members of the EERC are elected officials and may have received campaign contributions from unions representing City workers and/or their leadership or representatives, creating a conflict of interest that is not in the best interest of the citizens of Los Angeles;

Proposed Motion

THEREFORE, the South Robertson Neighborhoods Council requests that all meetings of the EERC be open to the public and transparent;

THEREFORE, South Robertson Neighborhoods Council also requests that seven (7) representatives, one from each of the Planning areas of the charter authorized Neighborhood Councils, be appointed to the EERC so that the Neighborhood Councils are better able to advise the Council pursuant to the Charter;

THEREFORE, South Robertson Neighborhoods Council requests that all labor negotiations between the Department of Water and Power and its union be conducted by the Department's management and be open to the public and transparent; without undue interference from the EERC, the City Council, and the Mayor;

THEREFORE, South Robertson Neighborhoods Council requests access on a timely basis to any and all information regarding compensation and benefits and how they compare to other comparable entities;





THEREFORE, South Robertson Neighborhoods Council requests that the EERC inform Neighborhood Councils on a timely basis as to the status of any labor negotiations and the impact on the City's budget over the following five years;

THEREFORE, South Robertson Neighborhoods Council requests that Neighborhood Councils be given 60 days to review and analyze any labor agreement and its work rules and the impact on the City's finances;

THEREFORE, South Robertson Neighborhoods Council requests that a council file be opened on all negotiations with any and all unions, and that Neighborhood Councils are given enough information and time to be able to review data and weigh in through council statements to be entered into the council file.
