

Background

Clean streets and sidewalks in our commercial areas has always been a priority for Soro NC. In past years this was a function of the Green Team Committee that was handled by Soro Stakeholders on a volunteer basis. The Green Team has not been an active committee for a number of years. Our last clean up was in Mid 2019 when the NC paid approximately \$4800 to a commercial company to clean up Robertson Blvd from Cadillac to Catteraugus.

Our commercial areas today need clean up now and for periodic follow ups. It is not economically practical to pay for continual clean ups by a commercial establishment. There is no active Green Team Committee at this time. The Business Advocacy & Development Committee feels that promoting clean, attractive commercial streets will increase economic viability and profitability of merchants operating within the boundaries of Soro. We want our purview revised to permit this committee to assist with keeping our commercial streets clean and attractive. If the Board agrees our committee will promote self -help to our existing Soro merchants. We will also provide equipment to allow merchants to clean their streets on a street-by-street basis. Some of this equipment we already have through prior purchase by the Green Team. Some will have to be purchased. Attachment "A" is a list of equipment needed that is presented as if we had to purchase all new equipment. Note that this list may be overstated by about 50% if most of the equipment in our storage unit is useable.

Proposed Motion

That the SORO NC Board :

- 1. Amends the Business Advocacy & Development Committee purview to allow this committee to assist Soro stakeholders in keeping our commercial streets clean and attractive.
- 2. Agrees that the equipment shown in Attachment A is needed to accomplish this function and agrees to authorize purchase of the equipment in an amount not to exceed \$1500 subject to the limitation that all equipment shown on Attachment A that is currently owned by Soro and in usable condition will not be purchased.
- 3. Agrees that the Business Advocacy & Development Committee can organize clean up days in commercial areas of Soro and can make this equipment available to stakeholders who volunteer for the cleanup.
- 4. Agrees that the Business Advocacy & Development Committee can start clean ups at the earliest possible date even if equipment is not yet available.

Currently, landlords in the City of Los Angeles can prohibit tenants from owning dogs in rental units. A new study from Ohio State University has found that neighborhoods with higher dog ownership tend to experience fewer crimes. On December 6 of 2022, SORO NC Land Use Committee reviewed the proposed project to demolish an existing 2-story 8-unit apartment building and construct a new 5-story, 29-unit apartment building with 6 units reserved for Very Low-Income Households at 8521 Horner Street. Requesting three (3) On-Menu Incentives for a) Density Bonus 35% increase in Floor Area, b) 11' Height Increase, and c) 20% easterly Sideyard reduction.

The project Architect and Client Planning Representative gave a detailed presentation. Two neighbors gave Public Comment questioning the large scale of the proposed apartment in comparison to the predominately block of duplexes & 4-plexes, and the change it will bring to the neighborhood homogeneous quality of life. The Land Use Committee was torn between the advantage of adding 23 new market rate & 6 very low income rate apartments and effect on the neighborhood quality.
