

Coalition requests that all Neighborhood Councils submit a CIS to CF 23-0600 strongly requesting that the Neighborhood Council's annual funding be increased to \$100,000 for the next Fiscal Year.

In FY 2009-2010, all departments, including the Neighborhood Council System took dramatic cuts to their budgets to help the solvency of the city. Since that time, department budgets were restored to the original cuts and increased over time. The Neighborhood Council budgets were never restored and the funding was never increased to keep up with inflation. The Neighborhood Councils have been good stewards of the taxpayer funding and has been forced to do more with less. With Neighborhood Council meetings returning to in person, the costs to hold meetings for their stakeholders has increased. There are also many projects in the community that could be completed sooner in the community if the Neighborhood Councils had additional funding to complete those projects instead of waiting for the city to complete.
