These new apartment buildings apply for LA City Planning Density Bonus & Affordable Housing Incentives with only a "Ministerial" (administrative not discretionary) approval process for reduced Side Yards, increased FAR, Height increases, less Open Space... without presenting to SORONC Land Use review nor notifying neighbors / owners within 500 ft radius. Our first outreach area will be with SORONC stakeholders near 8767 W. Airdrome.
