Background

Hamilton High School has 100+ students classified as Limited English Proficient (LEP), and as of December 2024, only 1 student has been reclassified from English learner status to fluent English proficient status. The district goal is 40% (~ 40 students per year).

Most, if not all, English learners would benefit from more exposure to, and conversations with, fluent / native English speakers; and such exposure would help improve their language skills.

Hosting a meet-and-greet is a first step towards helping the school achieve the district goal. Furthermore, this event facilitates an opportunity for both students and stakeholders to engage and foster mutual understanding, thereby positively contributing to the overall South Robertson community.
