**Joel Weinberger said there is currently no right turn sign. However, he also added that he had mixed feelings asking for the city to perform a study while the ongoing budget crises deepens as this may require the city to make more cuts to things they are already required to cut.**

**Joseph Mollaie added that city would take too long to implement this; he added he has seen cars make left turns and almost get hit.**

**Ken Blaker added that he too knew people injured on this street; he stated he was in favor of the motion.**

**Beth Klein asked how much of an impact would such a sign have.**

**Joseph Mollaie said he himself had hit someone who was making a left turn on South Shenandoah.**

**Mallory Smith said that bollards had been run over in the area.**

**Laurie Levine asked if people adhered to right turn signs.**

**Beth Klein said it would be an issue of enforcement, without enforcement people would do whatever they want.**
