Additional

- 1. Report the encampment to the City of Los Angeles Homelessness Outreach Portal: You can report an encampment by visiting the City of Los Angeles Homelessness Outreach Portal at https://myla311.lacity.org/homelessness-outreach. This website allows you to submit a report and provide details about the location of the encampment.
- 2. Report the encampment to your council district: Each council district in Los Angeles has a dedicated team that handles issues related to homelessness. You can find the contact information for your council district on the City of Los Angeles website at https://www.lacity.org/your-government/elected-officials/council-districts.

3. Services provided by the council district: Once the encampment has been reported, the council district will work with the City's Homelessness Outreach Team to provide services such as:

Connecting individuals to housing and shelter

Providing access to health and wellness services Cleaning and maintaining the area Providing support for individuals experiencing mental health or substance abuse issues

It's important to note that reporting homeless encampment does not guarantee that the individuals living there will be removed. The priority is to connect them with support services and housing resources.
