**Aggravated Assault**

October 26, 2023, at approximately 1240 hours, on the 10200 block of Santa Monica Blvd. Victim opened the bathroom stall, not knowing someone was in the stall. The suspect pointed a gun, which caused the victim to flee.

**Burglary - Residential**

October 22, 2023, at approximately 0340 hours, on the 3300 block of Castle Heights Ave. The suspect(s) cut the chain link fence inside the covered apartment build garage. The suspect removed property belonging to multiple tenants in the building.

### **Grand Theft Automobile**

### **Additional**

I want to emphasize the importance of knowing the elements of the crimes described in my community report, particularly Part 1 Crimes as defined by the FBI. This knowledge is vital for several reasons:

1. Awareness: Understanding the elements of these crimes helps you recognize potential threats and be more vigilant in your surroundings. By knowing what constitutes a crime like Homicide, Rape, Robbery, Aggravated Assault, Burglary, and others, you can better protect yourself and your loved ones.
2. Prevention: When you are informed about the specifics of these crimes, you can take steps to prevent them. For instance, understanding the definition of Residential Burglary may encourage you to bolster your home security measures.

Below are the crime elements for Part 1 Crimes. Part 1 crimes are the serious offenses for which the FBI gathers national data.

**HOMICIDE**: The unlawful, willful killing of one human being by another.

**RAPE**

- **RAPE 1**: The forcible penetration, no matter how slight, of the vagina against the victim's will or where victim is incapable of giving consent.
- **RAPE 2**: The forcible penetration, against the victim's will or where victim is incapable of giving consent, of the anus (sodomy), of the genital or anal opening by use of object or body part other than the offender's genitalia, or by oral copulation.

**ROBBERY**: The taking or attempting to take anything of value from the care, custody, or control of a person by force or threat of force, violence and/or causing the victim fear.

- **HOME INVASION ROBBERY**: The unlawful entry of a personal residence in order to take anything of value from a person by force, violence and/or fear.
- **ESTES ROBBERY**: Shoplift/attempt from a business in which the element of force, threat of force, violence and/or causing the victim fear becomes a factor.

**AGGRAVATED ASSAULT**: An unlawful attack by one person upon another for purpose of inflicting severe or aggravated bodily injury.

**BURGLARY**

- **RESIDENTIAL BURGLARY**: The unlawful entry of a residence to commit a felony/theft.
- **HOT PROWL**: The unlawful entry of a personal residence while residents are home.
- **COMMERCIAL BURGLARY**: The unlawful entry of a business to commit a felony/theft.

**BTFMV**: Burglary/Theft from Motor Vehicle

- **BURGLARY FROM MOTOR VEHICLE (BFMV)**: Breaking into locked/secured vehicle in order to remove victim's property, interior or exterior of vehicle.
- **THEFT FROM MOTOR VEHICLE (TFMV)**: Opening unlocked/unsecured vehicle in order to remove victim's property, interior or exterior of vehicle.

**GRAND THEFT AUTO** (GTA): Theft of a motor vehicle, taken without having lawful access.

**GRAND THEFT PERSON** (GTP): Unlawful taking of property from the possession of a victim.

**THEFT**: Unlawful taking of another person's property.
